Authorize execution of a 48-month contract with PLAYERS CONCESSIONS INC., or one of the other qualified offerors to Request for Proposal TVN0053, to provide café management services for Zilker Park Café for an estimated revenue amount of \$558,000, with two 36-month extension options in an estimated revenue amount of \$418,500 per option period, for a total estimated revenue amount of \$1,395,000.

Additional Backup Information

The contract is for the management and operation of a food and beverage concession within Zilker Park at Barton Springs Pool. The café was originally built during the 1960s and contributes to the historic character of Zilker Park, which is listed as a National Register Historic District.

In the spring of 2015, the City conducted a public survey to better understand and develop clear project goals for the solicitation. The survey results garnered priorities for the concession such as healthy menu options and affordable pricing that were integrated into the requirements of the solicitation.

Players Concessions Inc. (Players) currently operates the food concessions at Morris Williams, Jimmy Clay/Roy Kiser and Lions Municipal Golf Courses. They will provide all equipment, supplies and staffing, janitorial services and other functions necessary for the turnkey operation of the concession. The café will continue to operate from 10:00am to sunset seven days per week. The menu will include items historically associated with the concession, including burgers, snow cones, ice cream, juices, sodas, as well as other drinks and snacks. In addition, Players will provide a selection of healthy menu items as an alternative to standard concession fare at an affordable price.

This request allows for the development of a contract with a qualified offeror that Council selects. If the City is unsuccessful in negotiating a satisfactory contract with the selected offeror, negotiations will cease with that provider. Staff will return to Council so that Council may select another qualified offeror and authorize contract negotiations with this provider.

A team of Parks and Recreations Department (PARD) and Office of Sustainability personnel with expertise in concession management and sustainable practices evaluated and scored the proposals and recommended Players for award. Evaluation criteria included a proposed concept and solution, business experience and personnel qualifications, financial capability and business plan, total revenue and local business presence.

Executing this contract is a top priority for PARD. The contract executed in 2004 has expired and the café is currently running under an interim contract until the new contract can be executed.
