Central Health Board of Managers

- The 9 member board consists of:
 - 4 appointments by Austin City Council
 - 4 appointments by Travis County Commissioners Court
 - 1 joint appointment between City Council & Travis County
- The current open seat is for a full 4 year term from January 1, 2016 - December 31, 2019.

Central Health Board of Managers - Open Call for Applicants

- Open Call for Applicants
 - An open call for applicants was conducted from October 6th - October 23rd.
 - A press release detailing the application process was advertised by:
 - Posting to the City of Austin's main webpage; and
 - Sending out to Corporate Public Information Office's media outlets; and
 - Providing to the Mayor, Council and their staff.

Open Call for Applicants

- Contacting Applicants
 - The City Clerk's Office board application is open year round regardless of vacancies.
 - Applicants who applied prior to the open call were provided the updated qualifications and criteria set out in the press release.
 - Applicants who applied during the open call were contacted to confirm receipt of application and asked to provide a resume and Statement of Intent.

Open Call for Applicants

- Committee Members were provided physical and electronic copies of:
 - A spreadsheet listing each applicant, their district of residency, gender, ethnicity, occupation, employer and their qualifications.
 - Copies of applications, resumes and Statements of Intent

Nomination Process-Next Steps

- Committee Members will:
 - Review applications
 - Individually select a short list of applicants for consideration of the full Committee.
 - A special called meeting including an executive session will be scheduled to discuss applicants for November 30th.
 - Committee will select which candidates to interview.
 - Interviews will be scheduled
 - Committee will make selection upon the completion of the interviews.

Appointment Process

- Once a recommendation(s) have been made by the Health & Human Services Committee, approval by the full Council is required.
- The Clerk's Office will add this to the standing board and commission appointment item on the Council agenda.
- December Council Meetings are scheduled for December 10th and December 17th.
