1. Please provide information on renewable contracts the number and types of customers that have received rebates for installing solar photovoltaic panels. Some categories of interest are: homeowners versus renters versus apartment owners, income category, zip code, income level, and other aggregated data that would help describe residential customers that typically benefit from solar rebates.

Regarding request above, we only gather data by zip code (including incentives provided, # of systems, and total kW, by zip). Please see attached map of installations.

2. Please clarify collection practices. What options does a customer have to avoid termination of service?

3. Mr. Cullick stated that AE provided data to Council on the top 5 companies that have deferred payment arrangements. Please provide a copy of the information provided to Council.

4. Please provide additional information on AE's 1673 FTE's (how many of those are in the field, i.e., power plants, linemen, servicemen, customer service. Please provide a breakdown of FTE's by the different divisions within Austin Energy.

5. On average how many contract employees worked for Austin Energy per month in 2104? Please provide a breakdown of contract workers by the different divisions within Austin Energy and the Cost.

Austin Energy has staff augmentation contracts with vendors like Apple One for Customer Care and DIR for IT for which we issue their employees an Austin Energy Contractor Badge; however, please note that not all contractors are issued AE Badges. We have other service contracts like those with vendors such as Mastec and Pike for which, when jobs are assigned, their labor force is sent out to do the job. We also have AE temporary employees that are hired and processed through our Human Resources IT system (Banner), yet who were issued Contractor Badges even though their employment was directly with AE and not associated with a contract, such as returning

retirees. Some contract employees are task-based and therefore come on and off multiple times depending on the tasks requirements. We may have a contract employee work a week, a month, several weeks or months or even a couple days depending on the task. This information request is not available and would require extensive research.

6. What is the average hourly rate paid by Austin Energy for contract employees? What is the average hourly rate paid directly to the contract employee?

For Contract Employees, we have varying rates that we pay per contract requirements; we do not have what the vendors pay their employees.


7. What is Mr. Cullick's plan and schedule for working with the community to develop an effective outreach and marketing campaign for ECAD?


8. Has Mr. Cullick made any progress in reaching City Public Service San Antonio to gather information on its customer service survey?

Perhaps the best convention for comparing two organizations is the J.D. Powers Customer Satisfaction Survey. It is nationwide and well-respected. Austin Energy participates in the survey, which has recently published as its 2015 report an analysis of 2014 data.

The data, provided Austin Energy in the past few weeks, show Austin Energy trailing CPS in all categories with relatively small differences in Power Quality and Reliability (29 points) and larger (nearly 100 points) in the Customer Service category. Our Customer Service and our Communications Department are working together to improve customer perceptions in all categories of the Power survey.
