

# THE LIBRARY COMMISSION MINUTES

REGULAR MEETING 26, October, 2015

The Library Commission convened in a Regular Meeting on Monday, October 26, 2015 at the Austin History Center, 810 Guadalupe St. in Austin, Texas.

Chair Patricia Dabbert called the Board Meeting to order at 6:30 p.m.

The Bylaws as amended were approved on Commission Member Wiggins' motion, Commission Member Bogucka's second on a 9-0 vote. Vice Chair Williams absent.
