REGULAR MEETING 12th of October, 2015

The Economic Opportunity Committee convened in a regular meeting on the 14th of September, 2015 in the Austin City Council Chambers at 301 West 2nd Street in Austin, Texas.

Chair Ellen Troxclair called the committee Meeting to order at 2:11 p.m.

1. APPROVAL OF MINUTES

Approve the minutes of the Economic Opportunity Committee meeting of September 14th, 2015.

Minutes were approved on Vice Chair Houston's motion and Council Member Casar's second on a vote of 3-0 with Council Member Pool absent.

Discussion by the Committee resulted in separating the resolution into two parts, 'Ban the Box' and 'Fair Chance Hiring'.

Vice Chair Houston motioned for affirmative vote on 'Ban the Box' to refer to council. Councilmember Casar seconds the motion, 3-0 passage with Pool absent from Committee.

Councilmember Casar motioned to require city staff to draft an operable ordinance that includes definitions and penalties. Motion fails on failure to gain a second.

Clarification by Chair stated: Affirmative vote on 'Ban the Box' should be forwarded to the full council, but committee was not prepared to vote on drafting an ordinance on any components beyond this action.
