<u>AMOUNT AND SOURCE OF FUNDING</u>: Funding in the amount of \$67,600 is available in the Fiscal Year 2015-2016 Capital Budget of the Austin Resource Recovery Department. Funding for the remaining 27-months of the original contract period and extension options is contingent upon available funding in future budgets.

The receptacles will match the design of the silver containers currently located on city streets.

If the City is unable to enter into a contract, the City will have to spot purchase new and replacement receptacles at an increased cost.
