

## M/WBE Summary

Public notice was given for the solicitation documents for CLMC549 Lindshire Lift Station Relief through the City's Vendor Connection web portal which resulted in 479 contractors receiving notification. Seven contractors obtained the bid documents and four bids were received and opened August 20, 2015. All the bids received were from certified MBE/WBE firms. AUSTIN UNDERGROUND, INC. submitted the lowest responsive bid of four bids received:
