City Council approved Ordinance 20120927-75 on September 27, 2012 for the creation of the Parking Benefit District (PBD) in the University Neighborhood Overlay (UNO) District. Revenue collection began on January 1, 2013. The original district was from Martin Luther King Jr. Boulevard to 29th Street and west of Guadalupe Street to Rio Grande Street. The proposed expansion would be west of Rio Grande Street to Lamar Boulevard and Martin Luther King Jr. Boulevard to 29th Street and San Gabriel Street. (The OWANA/Caswell Heights neighborhoods-Martin Luther King Jr. Boulevard to 24th Street and San Gabriel Street to Shoal Creek Boulevard will not be participating in this expansion) To date, revenue from the PBD has been used to install new sidewalks and bike lanes on 23rd Street and on Rio Grande Street from Martin Luther King Jr. Boulevard to 24th Street.

The expansion of the PBD to Lamar Boulevard was to take place after a majority of the new high rise apartment complexes had been completed. The addition of the new apartments in the past few years has created additional parking needs. As required by ordinance, the City surveyed the proposed expansion area and found that on average 123% of the parking spaces were occupied with little or no turnover. Note: the industry standard to propose paid parking is 75% to 80% occupancy or 1 to 2 parking spaces available per block to provide for easy access to parking for visitors and customers.

Expanding the PBD would enable staff to add an additional 335 parking spaces. Based on city experience, the University Neighborhood Overlay district is projected to earn \$101,000 a year.

Based on the parking survey information, and the positive response from the neighborhood public meeting, the Transportation Department recommends the expansion of the Parking Benefit District in the University Neighborhood Overlay District.

Funds will be allocated per the policies previously established by Council for Parking Benefit Districts.
