

## SMALL AREA PLANNING JOINT COMMITTEE PLANNING COMMISSION/ZAP REGULAR MEETING MINUTES MONDAY, OCTOBER 5, 2015

#### C. NEW BUSINESS

a. Adoption of bylaws — Discussion of adoption of bylaws for the Small Area Planning Joint Committee - A draft of the proposed bylaws was presented and reviewed, with the following discussion:

Meetings will be held monthly on either the  $1^{st}$  or  $2^{nd}$  Wednesdays. Survey will be submitted for the final choice of days, with the next meeting being held on the  $1^{st}$  Wednesday of November.

Committee will address further down the road whether any subcommittees will be formed.

Jean Stevens moved to adopt the bylaws as discussed at this meeting, with a second by Gabriel Rojas and was approved on a vote of 5-0. Board members Susan Harris and Jeffrey Thompson were absent.

**b. Establishing a standing meeting date and time** — Meetings will be held monthly on either the  $1^{st}$  or  $2^{nd}$  Wednesdays. Survey will be submitted for the final choice of days, with the next meeting being held on the  $1^{st}$  Wednesday of November. This was approved in a motion in the preceding agenda item.

Board members Susan Harris and Jeffrey Thompson were absent. Jean Stevens took over as chair at this time.

Mark Walters was asked to talk with Francis Reilly, former staff liaison of the Neighborhood Plan subcommittee, and bring back any outstanding South Austin Combined Neighborhood Plan issues, as well as the status on any remaining committee items.

e. Development and land use issues along the East Cesar Chavez Street corridor — Discussion of community members' request to restrict certain land uses along the East Cesar Chavez street corridor from I-35 to US 183 and to initiate a small area planning process to address development-related issue and associated community concernsmeetings with neighborhood representatives and COA legal department will be scheduled to explore options discussed at this meeting. Neighborhood representative meeting will be on the agenda for November, with legal being scheduled for December, January at the latest.
