Notification of issuance of a Request for Qualifications on August 12, 2015 through the City's Vendor Connection web portal which resulted in 1,144 firms receiving notice. The solicitation was obtained by 101 firms and 10 submitted qualifications statements. Three of the firms submitting were certified MBE /WBE firms.
