

**ORDINANCE NO. 20151217-059**

**AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND COSTS, AND WAIVING CERTAIN REQUIREMENTS FOR THE CITY CO-SPONSORED AUSTIN FARMERS MARKET EVENTS AT REPUBLIC SQUARE PARK AND TRIANGLE PARK, DURING THE 2016 CALENDAR YEAR.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** This is one of the City co-sponsored special events under Resolution No. 021003-40. The total fee waivers authorized for events during the 2016 calendar year are estimated at \$180,593. Additionally, the Austin Transportation Department refundable security deposit requirement of \$2,000 and the Parks and Recreation Department refundable damage deposit requirements of \$1,000 are also being waived. Any fee requirements above this total are the responsibility of the applicant.

**PART 2.** Council waives and reimburses certain fees for the City's co-sponsored Austin Farmers Markets as follows:




