

2016 Candidate Forum Venue Recommendations

During September and October 2016, the League of Women Voters --Austin Area will conduct moderated candidate forums in locations within the Austin City Council Districts where there are contested elections.

The five geographic districts that are eligible for an election are Districts 2, 4, 6, 7 and 10.

Each of the forums will be broadcast live on ATXN, will be replayed on ATXN, and will be available on demand at www.atxn.tv. The Communications and Public Information Office will work with KAZI FM 88.7 so that forums will be aired live on its radio broadcast as well as streamed live online at www.kazifm.org.

These dates were chosen because of no scheduled meeting conflicts with the City Council or various Boards and Commissions.

 Oct. 7, 14, 18, 21

Optional forum dates:

These dates include scheduled Council Committee or Boards and Commissions that are scheduled to end by 7 p.m. Communications and Public Information recommends that the bodies would be asked to adjourn at 6 p.m. to accommodate a forum.

 - Sept. 7 Mobility Committee
 - Sept. 19 Regional Affordability and/or Planning and Neighborhoods committees

Once the Ethics Review Commission approves the proposed venues, the Communications and Public Information Office will finalize a schedule. CPIO will also work with the League of Women Voters on the City Charter-mandated candidate questionnaires and candidate statements.
