

### M/WBE Summary

Public notice was given for this solicitation, CLMC550, through the City's Vendor Connection web portal which resulted in 481 contractors receiving notification. Eight contractors obtained the bid documents and four bids were received and opened on Bids were opened November 23, 2015. Three of the four bids received were from MBE/WBE certified firms. Austin Underground, Inc. submitted the lowest of four bids received:
