ANALYSIS / ADDITIONAL INFORMATION: Austin Resource Recovery (ARR) is actively pursuing the development of its [re]Manufacturing Hub project. In order to complete the remaining design requirements and begin construction, it requires the use of cash funding as opposed to debt.

If Council approves the sale of the land known as 4711 Winnebago Lane (District 2), ARR will have additional cash funding available to support its facility development and construction efforts. This Council action will recognize the revenue from this real estate transaction and enable the department to increase transfers out to its capital budget. The capital appropriation will support the previously mentioned [re]Manufacturing Hub project and any remaining funds will support other future facility needs.
