Discuss and take appropriate action on City of Austin reviews, approvals and letter to the Office of the Governor, Economic Development and Tourism Department (OG-EDT), Environment Impact Study (EIS), application, affidavits, local funding, match and reimbursement under the MERP.
- 3. Discuss and take appropriate action on application, qualification process and submittals for the 2016 X Games Austin Event and subsequent events under the Major Event Reimbursement Program (MERP). Review, discussion and take appropriate action on agreements, with the City of Austin and COTA to update such agreements to apply to the 2016 Event and subsequent events.
