HCP – USFWS 10(a)1(B) permit

- Allows the City of Austin to keep Barton Springs Pool open for recreation despite it being endangered species habitat
- 20 yr permit
- MOU between PARD and WPD
- Benefits of Daylighting:
 - Increase salamander habitat and improve resiliency of species
 - Replaces degrading pipe
 - Amphitheater returns to historical condition
 - Recreate historical waterway

- Salamander habitat








