## Background

- 2012 City Council resolution: develop recommendations on relocation standards and their implementation
- May 20, 2013: Neighborhood Housing & Community Development submit memo of recommendations to City Council
  - Incorporated feedback from stakeholders and recommendations from University of Texas Law School's Community Development Clinic

## Resolution 20151112-027 (Nov. 12, 2015)

- Initiates amendments to the Land Development Code to establish relocation assistance requirements for applicants of developments with the intent to demolish and/or renovate multifamily structures that will result in the displacement of tenants
- Consider temporary and emergency relocation standards as well
- Stakeholder feedback process to identify the needs of the community and to ensure the ordinance that is ultimately drafted is responsive to them
- The goal is to mitigate the negative impacts of displacement on the most vulnerable residents

## Purpose

- Currently, no comprehensive formal policy for assisting displaced tenants
- Redevelopment of several multifamily properties has resulted in tenant displacement over the last several years
- Displacement can have destabilizing effects on the most vulnerable in our city, including elderly, low-income, or disabled households

## Stakeholder Input

- 3 stakeholder meetings have been held
- Tenants who had been displaced around Austin shared their experiences and discussed their biggest challenges
- Tenant advocates and representatives from the development community discussed ways the development process could address these challenges
- Draft policy concepts are being reviewed and refined with several City of Austin departments

## Proposed Solutions to Identified Challenges

Challenge	Proposed Policy Solution
Moving expenses are costly and difficult to pay	Moving and relocation assistance for income-eligible tenants
Difficult to find affordable new housing, requiring a long time to find a suitable new home	One-on-one relocation assistance from a 3 <sup>rd</sup> party organization
Made harder by insufficient notice to	180-day notice of intent to tenants
vacate	90-day notice to vacate/flexible move- out period
Moving often requires changing schools; this is difficult on children in the middle of the school year	Provide info to tenants about AISD's policy of letting students finish school year at same school, even if they move
Security deposits are not returned in a timely manner	Relocation and moving payments to help tenants cover relocation costs

## Proposed Solutions to Identified Challenges

Challenge	Proposed Policy Solution
Tenants often do not know where to go or how to navigate the relocation process	Tenant Information Packet given to tenants with the notice to vacate, containing information on assistance, tenant rights, etc.  Tenant meeting(s) to discuss info
Some tenants need interpreting services	Interpretation services for a variety of languages would be provided to tenants; all materials would be printed in English and Spanish
Occupied units that will be demolished fall into disrepair and repairs are not made	Enforce existing requirements for repairs to be made by owner/developer
Tenants and property managers often experience antagonistic or ineffective interactions	Relocation assistance would be provided by a 3 <sup>rd</sup> party organization  Tenant right of action to sue if requirements are violated  Prohibitions on intimidation

## Additional Policy Recommendations

- Applicability
  - Permanent Displacement
  - Temporary Displacement
  - Emergency Displacement
  - Require applicants for site plans, demolition permits, building permits to disclose if work will displace tenants
  - Multifamily structures of 5 or more units
  - Other types of properties, such as mobile home parks?
- For projects accessing Planned Unit Development or density bonus programs, relocation assistance for eligible tenants would be funded by the applicant

## Other Input from Stakeholders

- Require reasonable/shorter look-back periods when landlords deduct late fees from security deposits
- Require security deposits be returned immediately
- Shorter (60-day) notice to vacate to tenants
- City provides initial notice and information packet to tenants (rather than property owner/manager)
- Model assistance payments after FEMA guidelines
- Recommendation that requirements should cover natural disasters
- Advance notice of rent increases for properties that will be redeveloped
