AUTHORIZE the GATRRS program manager to proceed with review, engineering, design, and implementation of connections to the GATRRS master site of TxDPS master site equipment as well as P25 Motorola radio system(s) owned by Permian Basin Regional Planning Council and City of Odessa, for improved regional interoperability.
- 8. AUTHORIZE the GATRRS program manager to proceed with testing and implementation of a proposed migration of Lost Pines repeater site frequencies to the Bastrop simulcast layer. (PowerPoint presentation.)
- 9. REVIEW GATRRS operational issues: System performance (in particular during 2015 Halloween flooding), security, interoperability with external radio systems, additional GATRRS system users, and system performance reporting.
