



MINUTES OF THE CITY OF AUSTIN HEALTH AND HUMAN SERVICES COMMITTEE

Approval of Minutes

1. Minutes

Council Member Garza moved approval of the Minutes from Health and Human Services Committee Meeting of December 11th, 2015, seconded by Council Member Troxclair, motion passes 4-0.

Citizen Communication: General

2. Speakers signed up prior to the meeting being called to order will each be allowed two minutes to address their concerns regarding items not posted on the agenda.

Discussion and Possible Action

3. Discussion and possible action on a resolution related to funding policy goals for social service contracts and the Health and Human Services Department. Sponsors: Council Member Delia Garza, Mayor Pro Tem Kathie Tovo, Council Member Ann Kitchen, and Council Member Leslie Pool (Council Member Delia Garza; Robert Kingham, HHS Manager, Austin/Travis County Health and Human Services Department; Mary McDowell, One Voice).

Committee discussed whether the budget policy adopted by Resolution 20141211-114 needs to be amended to direct the City Manager to develop as part of the annual budget process for Council consideration an annual increase to existing social service and workforce development contracts in an amount equal to, or greater than 3%, and maintains the policy

goal to incorporate an annual increase for the Health and Human Services Department in an amount equal to, or greater than, the annual percent increase in population growth in addition to any proposed budget increases for cost of living salary adjustments, health care costs, or fuel costs in future proposed budgets for Council consideration.

Motion by Council Member Garza to recommend to full Council the adoption of the proposed resolution directing the City Manager to develop as part of the annual budget process for Council consideration an annual increase to existing social service and workforce development contracts in an amount equal to, or greater than 3%, and maintains the policy goal to incorporate an annual increase for the Health and Human Services Department in an amount equal to, or greater than, the annual percent increase in population growth in addition to any proposed budget increases for cost of living salary adjustments, health care costs, or fuel costs in future proposed budgets for Council consideration, seconded by Council Member Tovo. The motion carries 3-1 with Council Member Troxclair opposed.

Updates from Health and Humans Services Community Partners

5. Central Health update on operations, services and access to health care for Travis County residents. (Christie Garbe, Vice President and Chief Strategy Officer).

Christie Garbe, Vice President and Chief Strategy Officer for Central Health provided the update on operations, services and access to health care for Travis County residents.

Discussion and Possible Action

4. Discussion and possible action to approve a resolution directing the City Manager to explore options and locations for the provision of safe, durable, 24-hour free public toilets (Mayor Pro Tem Kathie Tovo).

Committee discussed a resolution directing the City Manager to convene relevant Downtown stakeholders, including the Austin Resource Center for the Homeless, Front Steps, Caritas, the Salvation Army, the Downtown Austin Alliance, congregations, and other providers offering resources to the homeless to make recommendations about options, locations, and funding for the provision of safe, durable, 24-hour free public toilets.

Motion by Council Member Tovo to approve draft resolution with understanding that revisions will be made before it goes to full Council on January 28th, 2016, seconded by Council Member Garza. The motion carries 3-0-1 with Council Member Troxclair abstained.

Staff Briefing

6. Staff briefing regarding referral from Mayor's Office related to reducing Animal Shelter intake, including spay/neuter (Tawny Hammond, Chief Animal Services Officer).

Del Goss, Patt Nordyk, Pat Valls-Trelles, Ryan Clinton, Zoila Vega signed up to speak on the item.

Tawny Hammond, Chief Animal Services Officer provided a briefing on reducing Animal Shelter intake, including spay/neuter ordinance.

Animals Services to provide to the Committee information on how they comply with the City Code § 3-1-27 - REPORTING BY ANIMAL SHELTER.

The manager of an animal shelter shall file monthly reports with the health authority that include:

- (1) the total number of animals impounded;*
- (2) the total number of animals destroyed;*
- (3) a description of each animal impounded or under care of the animal shelter and the date of its impoundment or acceptance;*
- (4) the date of sale or disposition of an animal;*
- (5) the purchase price received from the sale of an animal, and the name and address of the purchaser;*
- (6) the amount of fees and expenses incurred or assessed for impound and care of an animal;*
- (7) the name of an animal's owner, if known.*
