1. CITIZEN COMMUNICATION: GENERAL

The first 10 speakers signed up prior to the meeting being called to order will each be allowed a three-minute allotment to address their concerns.

2. APPROVAL OF MINUTES

The motion to approve the June 30th, 2015, meeting minutes was made by Commissioner Paup, seconded by Commissioner Noyola, and was approved unanimously.

3. OLD BUSINESS

No old business was presented for discussion.

4. NEW BUSINESS

A. Presentation, discussion, and possible action on the mission of the Community Development Commission, Bylaws and logistical operations.

Jim Padilla, Neighborhood Housing and Community Development, gave the presentation. A motion to approve the Bylaws with universal changes was made by Commissioner Ed McHorse, seconded by Commissioner Fadelu, and was approved unanimously.

B. Election of Officers

Commissioner Noyola nominated Commissioner Paup for Vice Chair of the Community Development Commission; Commissioner McGhee nominated Commissioner Deshotel. The vote tally was five in favor of Commissioner Paup, five in favor of Commissioner Deshotel, and one abstaining. Election of the Vice Chair position was tabled until the October meeting.



Commissioner McGhee nominated Commissioner Rivera for Chair of the Community Development Commission; Commissioner Rivera was elected Chair unanimously.

- C. Select a minimum of three Commissioners to serve on the Housing Committee.**
Commissioners Paup, McHorse, Villalobos, Dailey and Rivera volunteered to serve on the Housing Committee. Chair Rivera appointed Commissioner Paup as Chair of the Housing Committee.

- D. Briefing and discussion on mission and programs administered by the Neighborhood Housing and Community Development Office.**
Erica Leak, Neighborhood Housing and Community Development, gave the presentation.

- E. Select one Commissioner to serve on the Joint Sustainability Committee per Austin City Council Resolution 20150604-048.**
Commissioners McGhee and Noyola both volunteered to serve on the Joint Sustainability Committee, necessitating a vote. Commissioner McGhee received six votes, and Commissioner Noyola received five. The selection of a Joint Sustainability Committee representative was tabled until the October meeting.
