PROPOSAL

Demolish a ca. 1923 house that was moved to the current site in 1953.

ARCHITECTURE

One-story, rectangular-plan, side-gabled, Cumberland-style frame house with double front doors, a central, front-gabled independent porch on ornamental metal posts; and single 1:1 fenestration.

RESEARCH

The house was built in 1923, and was originally located at 907 Holly Street; it was moved to the current location in 1953, possibly at the same time that the construction of I-35 through downtown Austin was beginning, as this house was located in a block of Holly Street that is now part of I-35. Paul O. Simms, a local real estate developer, is the applicant for the utility permits at the new site.

The first owner of the house was Alice Renois, who retained ownership of this house through two more marriages and widowhoods until around 1946. Alice Renois Davis Jackson was a native of Bastrop County, Texas. She never had an occupation listed in the directory, but at the time of the publication of the 1924 directory, she was the widow of Theodore Renois, a carpenter; he and Alice had lived at 1606 E.14th Street in Austin in 1922. In the 1927 directory, she is listed as Alice Davis, the widow of Thomas J. Davis, and by the time of the publication of the 1932-33 directory, she was Alice Jackson, the widow of Nathan Jackson. She had roomers in the house listed in the 1930 U.S. Census, but was living here alone at the time of the 1940 census, when she was a 70-year old widow.

The house was then owned by Joseph and Perfecta Almanza in the mid-1940s; he was a dishwasher at the Greyhound Coffee Shop, associated with the Greyhound bus terminal. He and Perfecta had several grown children living in the house, all employed. The house was a rental property in the late 1940s, and in 1953, it was moved from Holly Street to its current location.

The first owners and occupants of the house at the current site were Walter and Barbara Sankey, Jr., who lived here until around 1960. Walter Sankey, Jr. was a serviceman for Walker Tire Company. Around 1960, the house was purchased by John V. and Lillie Gomez, who lived here the rest of their lives. John V. Gomez was a mail handler for the Post Office; he was shot to death on S. 1st Street in 1971, but Lillie continued to live in this house. She was employed by Yaring's, a women's and children's clothing store on Congress Avenue.


STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use if possible; staff understands that the house has some serious mold problems, but the house is a good example of an unadorned Cumberland style house, a relatively rare style in Austin. If the house cannot reasonably be rehabilitated, the staff recommends release of the permit upon completion of a City of



BIOGRAPHICAL NOTES

Alice Davis Jackson (ca. 1923 – ca. 1934 and ca. 1938 – ca. 1946)

The 1930 U.S. Census shows Alice Davis as the owner of this house, which was worth \$3,000. She was a 60-year old Texas-born widow with no occupation listed. Her father had been born in Alabama; her mother had been born in South Carolina. She had 3 roomers in the house: Rachel Jones, a 39-year old Texas-born widow with no occupation listed; Robert Blalock, a 42-yedar old Texas-born carpenter; and Hans E. Hafner, a 43-year old Texas-born riveter for a construction company, whose parents had been born in Germany.

The 1940 U.S. Census shows Alice Jackson as the owner of this house, which was worth \$1,000. She was a 70-year old Texas-born widow with no occupation and lived here alone.

The 1940 U.S. Census shows John Gomez as the 10-year old son of Crescencio and Barilla Gomez, who rented their house at 2610 E. 4th Street in Austin. Crescencio Gomez was 28, had been born in Texas, and was a laborer in the concrete pipemaking industry. Barilla Gomez was 27, had been born in Texas, and had no occupation listed. John Gomez was the oldest of the couple's 3 children. All the children had been born in Texas. The family had lived in rural Caldwell County, Texas in 1935.

His 1971 death certificate shows that Johnny V. Gomez was living at 1703 Garner at the time of his death. He had been born in 1930 in Texas to Crecensio Gomez and Luisa Varela, and was married to Lillie Gomez. He was employed by the Post Office. He was the victim of a homicide, having been shot at 2420 S. 1st Street in Austin.
