**PROPOSAL**

---

Relocate two 19<sup>th</sup> century houses from the north side of 3<sup>rd</sup> Street to the south side of 3<sup>rd</sup> Street.

---

**ARCHITECTURE**

---

**606 E. 3<sup>rd</sup> Street**

One-and-a-half story, rectangular-plan mansard-roofed frame house with Cumberland-style double front doors and single 2:2 windows on the ground floor; partial-width independent porch on turned wood posts and with a spindlework frieze. Single and paired 1:1 windows in hipped-roof dormers projecting from the mansard roof. The house appears to have been originally one story with a hipped roof; the second-story mansard-roofed addition was made between 1900 and 1935.

**608 E. 3<sup>rd</sup> Street**

One-story, rectangular-plan, hipped-roof frame house with a full-width independent porch on turned wood posts; glazed front door; single tall 2:2 windows.

**RESEARCH**

---

**606 E. 3<sup>rd</sup> Street**

The house at 606 E. 3<sup>rd</sup> Street is believed to have been built around 1892 – it was a simple, one-story frame house with no front porch, as depicted in the Sanborn maps of 1894 and 1900. At some point between 1900 and 1935, according to the depictions in the Sanborn maps, the house was enlarged to its current 2 stories and a front porch added. It is more likely that this transformation occurred closer to 1900 than later, as the second story is a mansard-roofed addition, and the front porch has a spindle frieze, both of which would have been popular still at the turn of the 20<sup>th</sup> century.

The house appears to have been built (or at least first occupied) by Mrs. Louisa Huston, the widow of a surgeon and physician who served in the Confederate Army. Mrs. Huston was born Louisa Dryden in Virginia in 1825, and married James Huston in Callaway County, Missouri in 1841. According to an affidavit she filed for a pension claim on her husband's military service, she had lived in Travis County since 1875. She and her husband had made their home at what is now E. 1<sup>st</sup> and Water Streets before he died in 1878. She then moved from that house to a house on the east side of Red River Street between 2<sup>nd</sup> and 3<sup>rd</sup> Streets until the early 1890s. Whether the house that stands now was existing in the 1890s or whether Mrs. Huston built it is unclear, and will require further research into real estate records. However, it does seem clear that after around 1892, Mrs. Huston was living at this address on the north side of 3<sup>rd</sup> Street (rather than her former house on the south side of 3<sup>rd</sup> Street). She lived here until her death in 1901. Towards the end of her life, she shared the house with her daughter, Allie Huston Turner. After Mrs. Huston's death in 1901, the house was occupied by her daughters, Allie Huston Turner and Lizzie Stricklin, both widows. Allie Turner died (of nervous exhaustion) in 1914. Her daughter, Mattie Turner, who had been a dressmaker living on Willow Street, moved in with her aunt Lizzie Stricklin. These two women lived together in the house until Lizzie Stricklin's death in 1936. After that, Mattie Turner lived here until her death in 1952.

The house became a rental property after Mattie Turner's death, and then became commercial property in the 1980s, as an antique shop owned by W. Cleigh Nease and Thomas B. Cowley.

### **608 E. 3<sup>rd</sup> Street**

The house at 608 E. 3<sup>rd</sup> Street appears to date from an earlier time than the house at 606 E. 3<sup>rd</sup> Street; it is also, even when comparing the original sections of both houses, a more modest dwelling. The house appears on the 1894 Sanborn map as well as the 1900 map as a simple box with a full-width front porch. The maps of 1935 and 1961 show that additions were made to the back of the house, but the original look and façade of the house retain their historic appearance.

Unlike the house next door at 606 E. 3<sup>rd</sup> Street, which was maintained by the same family for generations as their family residence, this house has been a rental unit for the majority of its existence. Although staff believes that the house dates from the 1880s because of its architectural characteristics, city directory research only takes us as far back as 1903, and more research is needed to complete the history of this house. The house was rented by a series of working-class families in the early 1900s, including a waiter, a cook, barbers, a clerk at a news and cigar parlor, an electrician, and a beer truck driver. Several of the early tenants were of German heritage, dovetailing with the German family who owned the store and houses at the corner of 3<sup>rd</sup> and Red River Street at the turn of the 20<sup>th</sup> century. In the mid-1950s, Mabel Walker, the owner of the Walker Rest Home next door at now-demolished houses just to the east of this house, lived here for a short time. Like the house next door, it was vacant for a short period in the early 1980s, then became a commercial property, housing an interior design firm.

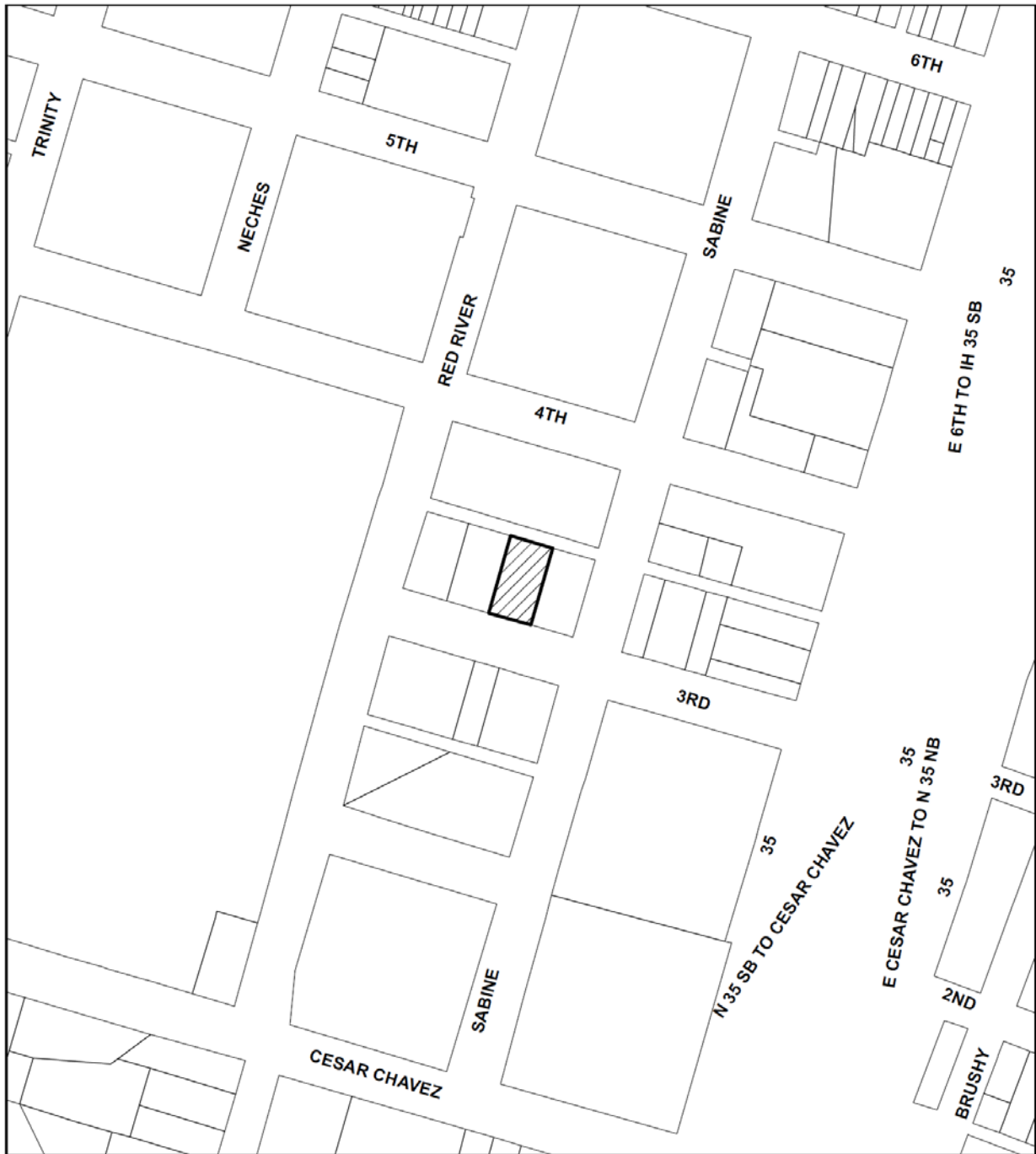
Both houses are listed as Priority 2 for research in the Comprehensive Cultural Resources Survey (1984).

Further confirmation of this is that the city directories of the early 1880s show Louisa Huston living on the east side of Red River Street between Cypress (3<sup>rd</sup>) and Live Oak (2<sup>nd</sup>) Streets, which would correspond to the south side of 3<sup>rd</sup> Street, rather than the north side of the street, where the house is located.

#### **BIOGRAPHICAL NOTES:**

Lizzie Stricklin appears in the 1930 U.S. Census as the owner of this house, which was worth \$1,500. She was a 78-year old widow who been born in Missouri and had no occupation listed. Mattie Turner is listed as a roomer in the house. She was a 69-year old widow who had been born in Texas, and was a dressmaker. They had another roomer, Emmett P. Miller, a 33-year old divorced man who had been born in Texas and worked as a machinist in a blueprint company.

The 1920 U.S. Census shows Mattie Turner and Lizzie Stricklin at this address. Lizzie Stricklin was a 68-year old widow who is listed as the owner of the house; Mattie Turner was a 59-year old widow who is listed as the renter. Neither woman had an occupation listed.



The 1910 U.S. Census shows Lizzie Stricklin living in this house with her sister, Allie Turner. Lizzie Stricklin was a 58-year old widow who had been born in Missouri and had no occupation listed. Allie Turner was a 60-year old widow who had been born in Missouri and had no occupation listed.

The 1900 U.S. Census shows Mattie Turner as the wife of R.E. Turner; they lived at 1421 Willow Street in Austin. R.E. Turner was a 40-year old Texas-born day laborer. Mattie Turner was 39, had been born in Texas, and had no occupation listed. They had 6 children: Mackie, 23; Lizzie, 15; Annie, 13; Lora, 11; Alice, 8; and Paul, 3.

The 1910 U.S. Census shows Mattie Turner as a 49-year old widow living at 306 Willow Street. She worked as a dressmaker. She had 2 children living with her: Alice, 18; and Paul, 13. Neither of the children had an occupation listed.

The 1900 U.S. Census shows Allie Turner as the daughter of [?] Huston, who lived at this address. Neither was employed.

Mrs. Louisa Huston's application for a Confederate pension for her husband, James Huston shows that she was living at 606 E. 3<sup>rd</sup> Street in Austin at the time of her application. She was married to James Huston on May 4, 1841 in Callaway County, Missouri. He was a surgeon in the Confederate Army and served from the beginning to the end of the war. She had lived in Travis County since 1875.

Louisa Huston died in Travis County June 25, 1901. She is buried at Oakwood Cemetery. Allie M. Huston Turner died in 1914. Her death certificate shows her address at 606 E. 3<sup>rd</sup> Street; she died of nervous exhaustion at the age of 64.

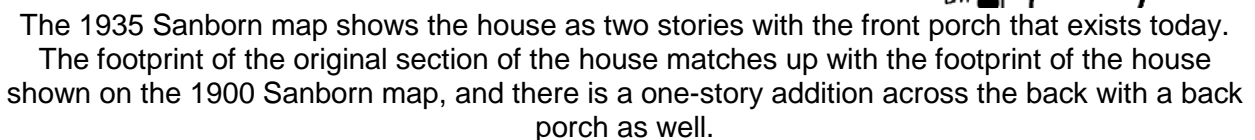

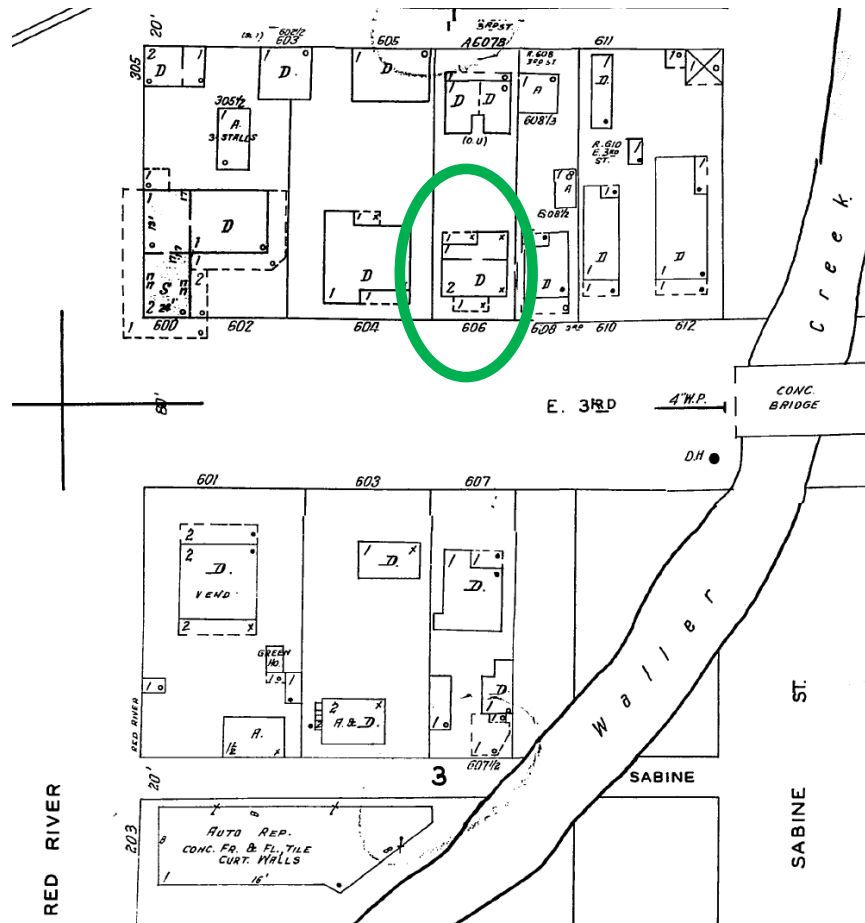

### **BIOGRAPHICAL NOTES:**

#### **Oscar and Helen Sussdorf (ca. 1909- ca. 1911)**

Oscar and Helen Sussdorf appear in the 1920 U.S. Census as the owners of the house at 808 Willow Street. Oscar Sussdorf was 43, had been born in Germany, and was a laborer in a restaurant. Helen Sussdorf was 33, had been born in Texas to German-born parents, and had no occupation listed. They had 4 daughters, all under the age of 8. The 1900 U.S. Census shows Oscar Sussdorf as the 23-year old son of Fred and Johanna Sussdorf of Comal County, Texas. Oscar and his parents had been born in Germany; they came to the United States in 1881. The family included younger children who had been born in Texas. Fred Sussdorf is listed as a landlord; Oscar Sussdorf was a farm laborer.

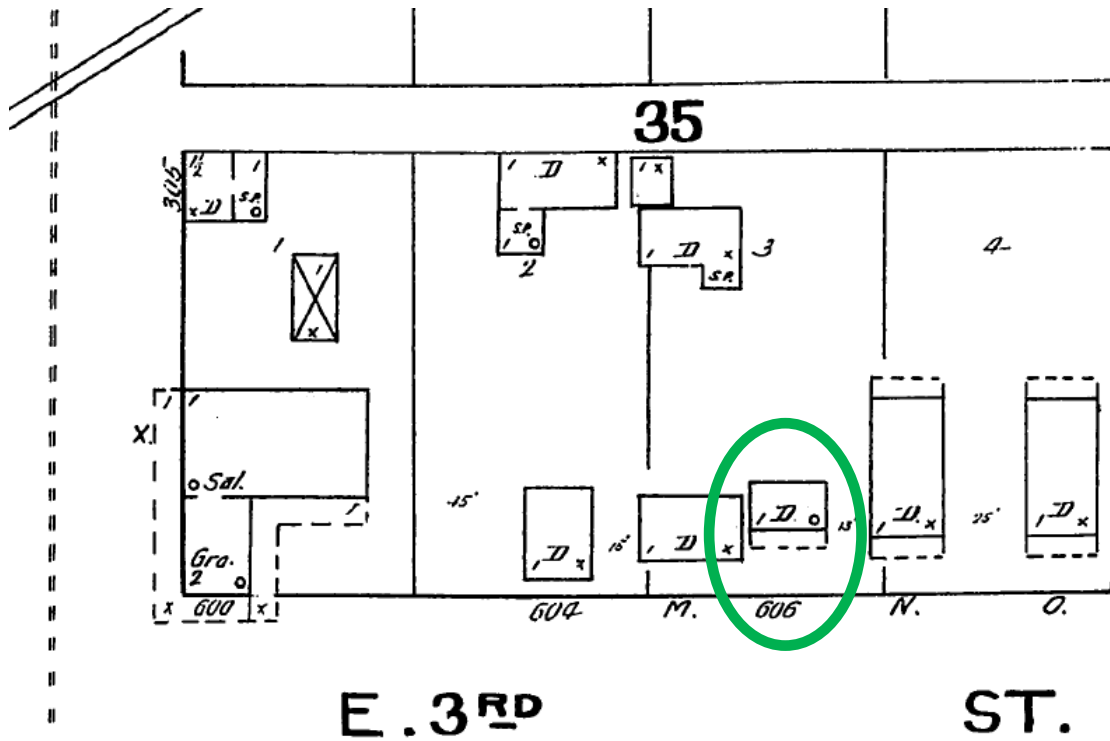
His 1918 World War I draft registration card shows Oscar Sussdorf was living at 808 Willow Street. He was born July 26, 1876 in Germany. He was a waiter at Kriegel's Restaurant at 315 E. 6<sup>th</sup> Street. He was of medium height and slender build.

**Thomas and Rose Dougherty (ca. 1930 – ca. 1936)**

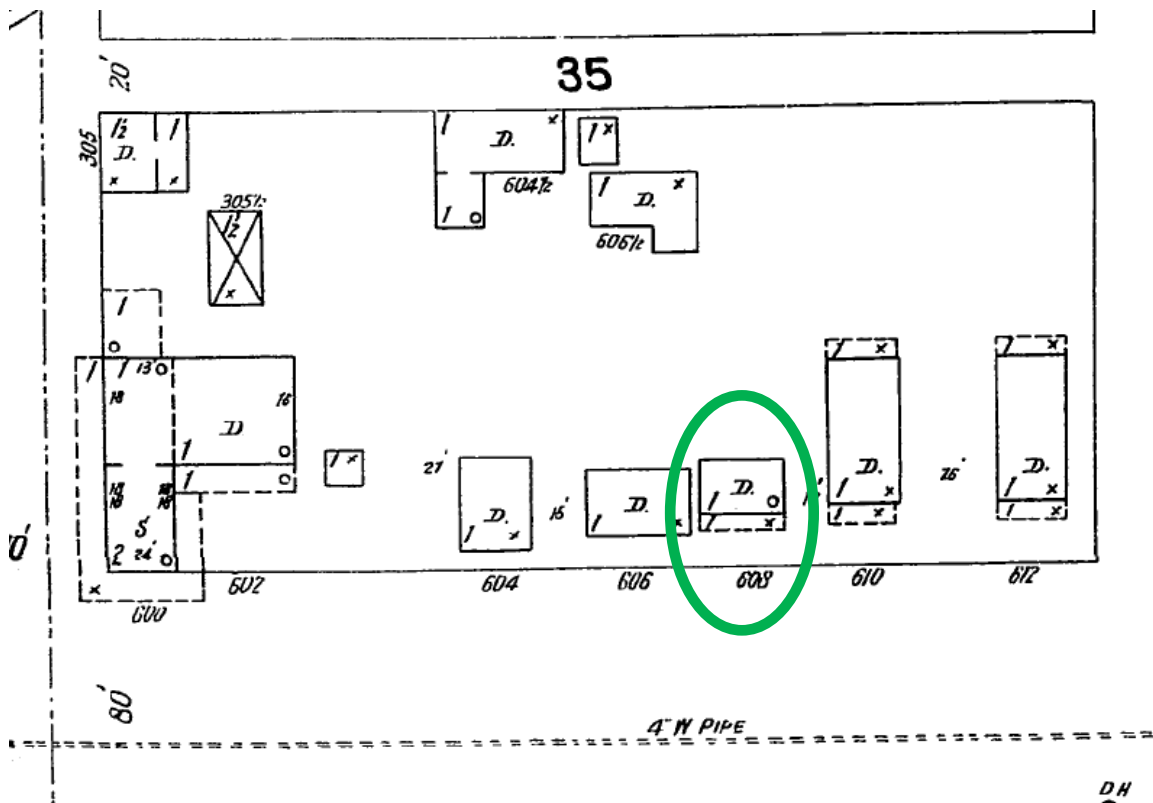
The 1930 U.S. Census shows Thomas and Rose Dougherty as the renters of the house at 607 ½ E. 3<sup>rd</sup> Street. Thomas Dougherty was 44, had been born in Texas, and was a soda water salesman. Rose Dougherty was 33, had been born in Texas to German-born parents, and had no occupation listed. They had a 1-year old daughter, Mildred.

**Sanborn maps**

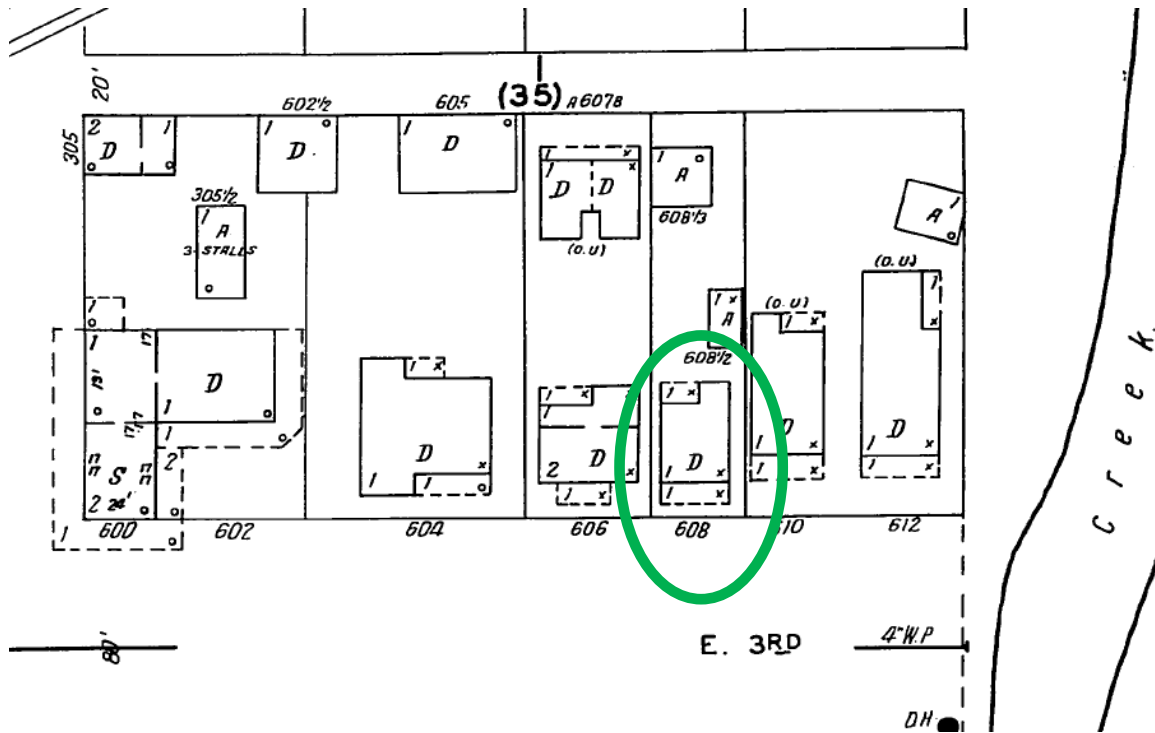
The Sanborn maps of 1894 forward show this area of the city. This neighborhood does not appear on the 1889 map. The house appears on the maps of 1894 and 1900 as a one-story house with a full-width front porch; the maps of 1935 and 1961 show rear additions and the rear porch were added.
