1. APPROVAL OF MINUTES

Council Member Casar motioned to instruct staff to draft the Fair Chance Hiring Practices Ordinance for Council excluding the requirement for DPS records and follow the records retention for those employers larger than ten employees with Vice Chair Houston's second on a vote of 3-1 with Chair Troxclair voting against.
