Authorize award and execution of a construction contract with SANTA CLARA CONSTRUCTION, LTD. for the North West Brentwood Karen and Payne Area Neighborhood Water System Upgrades project in the amount of \$2,434,207 plus a \$243,000 contingency, for a total contract amount not to exceed \$2,677,207.

Additional Backup Information	

The NW Brentwood Karen & Payne Area Neighborhood Water System Upgrades project is part of the Renewing Austin Program. Renewing Austin is an ongoing program to replace and upgrade deteriorated aging water lines with multiple break history as well as wastewater lines in need of replacement that fall within the project area.

The work consists of the installation of approximately 9,910 linear feet of water mains and installation of 1,332 linear feet of wastewater lines. Also included is the abandonment of 538 linear feet of existing 2-inch water line, 4,865 linear feet of existing 6-inch water line, and 3,085 linear feet of existing 8-inch water line parallel to the newly proposed 8-inch water line throughout the project. This project will also remove redundant pipe within the water system.

Due to the potential for unknown subsurface conditions and utility conflicts, a 10% contingency in funding has been included to allow for the expeditious processing of any change orders. A contingency is an additional amount of money added to the construction budget to cover any unforeseen construction costs associated with the project.

Area stakeholders were informed of this project during its design process and will continue to be informed throughout the construction process by way of periodic electronic communications, special hardcopy notices delivered in advance of construction phase changes or in the case of substantial project impact, and face-to-face coordination meetings when necessary.

A delay in execution of this contract would mean a delay in replacing deteriorated water mains with the history of multiple breaks which could lead to water main breaks that impact water supply to citizens.

The contract allows 270 calendar days for completion of this project. This project is located within zip code 78757 (District 7). The project will be managed by the Public Works Department.
