

## M/WBE Summary

Solicitation documents for this Invitation for Bid were distributed to 521 contractors using the City's Vendor Connection web portal. 14 general contractors obtained the bid documents and five bids were received. Bids were opened on January 14, 2016. Three out of five bids received were certified MBE /WBE firms. Facilities Rehabilitation Inc. submitted the lowest responsive bid of five bids received:
