<p>Authorize award and execution of a 36-month contract with WOODS MAINTENANCE SERVICES, INC., to provide graffiti removal services, in an amount not to exceed \$270,000, with three 12-month extension options in an amount not to exceed \$90,000 per extension option, for a total contract amount not to exceed \$540,000.</p>

<p>Funding in the amount of \$45,000 is available in the Fiscal Year 2015-2016 Operating Budget of the Building Services Department. Funding for the remaining 31 months of the original contract period and the extension options is contingent upon available funding in future budgets.</p>

The contract will provide for graffiti removal services, including all labor and materials, at City facilities and parks. The contractor will provide graffiti removal services City-wide on an as-needed basis. Graffiti removal by environmentally preferable chemicals, repainting using low-volatile organic compound (low-VOC) paints, and remediation using power washing or abrasive media is included in this scope of work. Building Services Department maintains facilities throughout the City and will coordinate graffiti removal activities for all City departments.

The City recognizes that graffiti has become an increasing problem with both public and private properties being marred with unauthorized markings, slogans, offensive language and symbols. Moreover, graffiti serves to mark out territories of youth gangs and is closely related to juvenile gang activity, while devaluing property and reducing the aesthetic appeal of the city.

Pursuant to City Code §9-4-43 graffiti that is visible to the public is prohibited on both public and private property. On March 23, 1995, Council adopted an Ordinance No. 950323-K that directed the City Manager to implement a system that removes graffiti from city property within 30 days after notice of its existence. The amount of graffiti to be removed exceeds the City's staff capacity. For the City to comply with the ordinance requirements, this contract is needed to subsidize this needed service.
