Additional Backup Information				

The contract will provide reflectorized pavement markers (RPM) for the Traffic Signs and Markings Division of the Transportation Department. RPM will be installed on the surface of roadways throughout the City to delineate traffic lanes. This improves visibility of lanes during nighttime and wet conditions. The RPM include a red reflective face on the side that is facing opposite traffic to deter wrong way drivers. The City installs and maintains more than 50,000 RPM annually.

If the City is unable to enter into a contract, RPM's cannot be installed resulting in violation of Texas Department of Transportation Manual of Uniform Traffic Control Devices and would affect safety on the road ways.
