

M/WBE Summary

Public notice was given for this solicitation, CLMC576 East 7th Street and Pleasant Valley Intersection Improvements project, through the City's Vendor Connection web portal which resulted in 420 contractors receiving notification. Ten contractors obtained the bid documents and three bids were received and opened on February 4, 2016. Two out of three bids received were certified MBE/WBE firms. Muniz Concrete & Contracting Inc. submitted the lowest responsive bid of three bids received:
