Objective/Goals

Objective:

Provide a status update on the Asian American Resource Center's Senior Lunch Social Program and catering solicitation. Seek a recommendation from the Asian American Quality of Life Advisory Commission to negotiate and execute an agreement with selected vendors.

Goals for the Program:

- 1. Create a more efficient program using renovated commercial kitchen with a Food Establishment Permit
- 2. Create a more sustainable program with long-term contracts (up to a five-year period) with multiple vendors.
- 3. Expand the program by increasing service delivery from three days to four per week (Monday Thursday) and increasing the number and variety of meals served.

Solicitation Process

- Corporate Purchasing Office issued a Request for Proposal (RFP) SMB0101 for catering services on December 21, 2016
 - Approved without MBE/WBE goals by the Small Minority Business Resources
 Department.
- Pre-Proposal Conferences held on January 11, 2016 at 10:00am and 2:00pm at the Asian American Resource Center
- Original closing date was February 4, then extended deadline to February 17, 2016 to accommodate potential bidders
- Five (5) proposals received, one of which was deemed non-responsive
- Evaluation Panel met on March 3, 2016
- Taste Testing was held on March 24, 2016
- No vendors or bidders have expressed complaints or opposition to date

Outreach Efforts

- Provided Corporate Purchasing Office with contact information of local Asian restaurants to include in solicitation email notification
- Placed paid advertisements in local ethnic print media (Austin South Asian, Capitol News, Epoch Times and News Korea)
- Shared solicitation through our e-newsletter (over 2,000 subscribers).
- Printed flyers for public distribution
- Presented solicitation to the Asian American Quality of Life Commission for public dissemination
- Provided information to Austin's Network of Asian American Organizations at monthly board meeting
- Participated at the Greater Austin Asian Chamber of Commerce's Quarterly Connect Forum for Minority Businesses
- Provided staff for interpretation services in Mandarin, Vietnamese and Korean

Solicitation – Evaluation

- Local Business Presence (yes/no)
- Cost (pre-determined percentage)
- Program (variety of cuisines served, menu options)
- Experience & Qualifications (recommendations, past work experience)
- Taste Test (two examples of prepared lunches)

Next Steps

- Reviewed by the Concessions & Contracts Committee (Parks & Recreation Board) on April 12; Made recommendation to approve
- Review by the Parks & Recreation Board on April 26
- Item to approve the negotiation and execution of an agreement by the Austin City Council on May 19
- Catering services to begin on June 1, 2016 with up to 60 meals offered four days per week
- Estimated commercial kitchen project completion is October 2016

Requested Commission Action

Staff requests that the Asian American Quality of Life Advisory Commission make a recommendation to the City Council to authorize the negotiation and execution of an agreement with the four selected vendors to provide hot meals for the Asian American Resource Center's Senior Lunch Social Program.
