

M/WBE Summary

Public notice was given for this solicitation, CLMC555A Miscellaneous Erosion Control Projects, through the City's Vendor Connection web portal which resulted in 794 contractors receiving notification. 11 contractors obtained the bid documents and five bids were received and opened on February 4, 2016. Two out of the five bids received were certified MBE /WBE firms. Santa Clara Construction, Ltd. submitted the lowest of 5 bids received:
