- E. Recommendation number 201602084D Supporting the Muslim Community of Austin
  - Commissioner Alba Sereno motioned to accept the resolution.
  - Commissioner Pedro Villalobos seconded the motion.
  - Motion passed 10-0.
  - Please note that the Asian American Quality of Life is also looking into passing a similar recommendation as the Human Rights Commission.
- F. National Immigrant Heritage Month Events and Proclamation
  - Every June is National Heritage Month.
  - A draft recommendation was presented to the Commissioners to proclaim June 2016 as "Immigrant Heritage Month".
  - The Commissioners discussed the possibility of holding a community event. Recommendations for the event to be proposed at the June meeting.
  - We need to think about where the Welcoming Initiative needs to be housed and allocation of budget. Chair Angela-Jo Touza-Medina to lead the recommendation of where it needs to be housed along with the assistance of Commissioner Alba Sereno.
  - Specific suggestions for Immigrant Heritage Month Events Suggestions:
    - i. Have community event
      - Ask Ryan Robinson, the demographer, to come present data on that.
      - Include a summary of what the commission has done since the inception of the new body.
      - Keynote on what does immigrant mean? Different reasons? What countries do people come from?
    - ii. Press conference on June 30<sup>th</sup>
      - For the press conference, send an invitation to everyone featured in
        - the stories plus the Mayor and all of the City Council members.
    - iii. Four (4) part news blast

- Commissioner Alba Sereno to create an outline of the newsletter and forward to Staff Liaison Connie Gonzales and she will forward information to all. Everyone to enter their name by story.
- Story to contain the following pieces: human interest; stats; and policy. Parameters will need to be set. Imagine Austin has some criteria that we will want to incorporate into the story and the final piece to show who your Commissioners are.
- There are several issue areas:
  - a. Tech Big business
  - b. Music Student, Professor
  - c. Business Small business (food trucks)
  - d. Education
  - e. Round out with community initiatives
- The information to be sent to the listserv. The listserv was gathered by the previous board members. An approximate total of 2,000 people. The listing might consist of allies, a suggestion of contacting the Public Information Officer (PIO), Public Safety Office, and other Commissions.
- The newsletter has usually been a summarization of what's been going on, all the policies recommendations that have been made, providing rotating information on the incoming commissioners.
