I would like to thank you once again for your service on this commission and for your patience in considering the complaint filed and now twice amended by Mr. Clark.


On April 13th, I attended the scheduled preliminary hearing eager to take the opportunity to answer any questions or concerns you may have about this issue. As I mentioned in my earlier letter to you, from my time as a candidate in 2014 and during the first three months while on Council in 2015 my and I rented out the front part of our home as a Short Term Rental – Type 1. Like many we rented out the front part of our home to supplement our fixed income and to help pay for the skyrocketing property taxes. During this time we were properly licensed, paid our taxes, disclosed our all required financial forms, and thankfully kept our receipts.

As you can see by the copy of my STR Type 1 Operating License, included with this letter, we chose not to renew the license in April 2015. Therefore, by the time City Council began considering regulations on STRs at the end of summer 2015, we had not been licensed nor did we operate an STR Type-1 for several months prior. Correspondingly, public record shows, that we paid Hotel Occupancy Taxes throughout 2014 ending in quarter 1 of 2015 when we decided not to run an STR anymore and therefore did not need a license. I've included those receipts as well.

Having shown fully, with public records, that I did not own nor did I operate an STR while considering regulations on STR's I am confident you will see this baseless allegation for what it is. It is an attempt by from profit driven interest to co-opt and overturn our civic process for personal financial gain.
