3. Review and Approval of February Meeting Notes

Sofia Benner motioned to approve the minutes for February, with the addition of a few minor changes noted by various members. Stanton Truxillo seconded. Meeting Summary unanimously approved.

4. SH71 Express Project: Discussion and Possible Action

Emily Riggs, TxDOT Public Information Coordinator, gave the presentation, which included background information on the project and the project corridor, information on the Texas Department of Transportation, the Central Texas Regional Mobility Authority, and McCarthy Building Company's roles in the project, a project overview and timeline, before & after renderings, Shared Use Path progress, traffic impacts, environmental protection, and ways to stay connected with the project. Mobility Talks: Discussion and Possible Action

Mike Trimble, Capital Planning Office gave the presentation, which included Background, Community Priorities, Project and Program development, Universe of Needs, and Community Engagement. The following discussion among BAC members focused on types of projects and programs that have received bond funding in the past, the trade-offs associated with funding various mobility priorities, street reconstruction and maintenance, metrics for congestion, and measuring equity.

Recommendation language based on a recent recommendation on Mobility Talks passed by the Urban Transportation Commission was presented.

Action taken: The resolution passed unanimously with the following amendment: change "WHEREAS funding the Bicycle Master Plan could remove an estimated 20,000 car trips from the Central Business District every day" to "WHEREAS funding the Bicycle Master Plan could increase mobility by 170,000 trips in the City of Austin every day". 5. Vision Zero Action Plan: Discussion and Possible Action

Frances Reilly, Planning and Zoning Department, gave an overview of the Vision Zero Action Plan and outlined the recent revisions made to the draft of the plan, which include organizing the proposed actions into five categories (Evaluation, Engineering, Enforcement, Education, and Policy), the inclusion of cost estimates for each action, and an increased focus on design & equity throughout the plan. Tom Wald, BAC member, presented the draft recommendations of the Travis County Bicycle Safety Task Force, which was appointed by the Travis County Commissioners Court to improve bike safety in unincorporated areas of Travis County by determining how to spend the 2011 Bike Safety Project funds.
