

URBAN RENEWAL BOARD APPROVED MINUTES

REGULARMEETING April 18, 2016

The Urban Renewal Board convened in a regular called meeting on Monday, April 18, 2016 at the Street-Jones Building, 1000 East 11th Street in Austin, Texas.

Chair Clark-Madison called the Board Meeting to order at 6:02 p.m.
