



**THE LIBRARY COMMISSION  
MINUTES**

**REGULAR MEETING  
23, March, 2016**

**The Library Commission convened in a Regular Meeting on Wednesday, March 23, 2016 at the Austin History Center, 810 Guadalupe St. in Austin, Texas.**

**Chair Patricia Dabbert called the Board Meeting to order at 6:03 p.m.**

- 1. Citizen Communication:** Carlos León talked about computer access at the Manchaca Road Branch and requested that the building plaque at Old Quarry Branch be cleaned.
- 2. Approval of Minutes from February 24, 2016 Regular Meeting**
