

M/WBE Summary

Public notice was given for this solicitation, CLMC570 the Davis Water Treatment Plant 35th Street Main Power Feed Replacement project, through the City's Vendor Connection web portal which resulted in 185 contractors receiving notification. Six contractors obtained the bid documents and five bids were received and opened on April 7, 2016. Two out of five bids received were certified MBE /WBE firms. Santa Clara Construction, LTD submitted the lowest of five bids received:
