What is a Community Garden?

A community garden is "any piece of land gardened by a group of people" - American Community Gardening Association




Benefits of Community Gardens

- Re-engage people with their food
- Provide spaces created BY the community for people to learn to grow food, enhancing community stewardship and pride
- Provide access to affordable, fresh, local, culturally appropriate, nutritious food
- Foster friendships and cooperation across racial, socioeconomic, and age groups
- Empower citizens to relate with local governments



All this around food and health—common to all.

Existing Community Gardens in Austin

- Gardens are on City, County, State, church, school, and private land.
- Gardens are under a variety of land use agreements, including license agreements, Parkland Improvement Agreements, and private land use agreements.
- Most gardens on City land have a waiting list (some with over a year wait). There is a growing demand for community garden space.
- Most gardens are managed by volunteer participants.
- Most gardens have plot rental or membership fees to cover water and other costs

Progress Assessment of Original Community Garden Policy Goals

- Using 2009 CG advocacy goals, revisited each policy need and determined 2016 status:
 - Complete, In Progress, No Action
- Full progress assessment on separate document for your review

Barriers: SUACG Program Staffing

RECOMMENDATION

"Estimated fiscal impact was calculated by the City Budget Officer to be \$859 from PARD per each community garden request (34 hours of staff time from an **Administrative Senior**, **Planner II**, **Program Coordinator**, and a **Landscape Architect**) plus 40 hours of staff time for an **Engineer Associate C** who could work with the sustainable food group. The fiscal impact of adding necessary PARD program staff was \$90,000 for salary and benefits for two new full-time FTEs (one Administrative Senior and one Program Coordinator)."

Barriers: SUACG Program Staffing

CURRENT STATUS

- Lack of City of Austin Community Garden Program staff capacity
 - Only 0.5 FTE Program Coordinator is funded within PARD
- Lack of support from additional staff in key departments
 - CG assistance should be in job descriptions of relevant staff, as originally indicated by City Council ordinance back-up documents
 - Assistance with community garden process is interpreted as not part of regular job duties by other city staff, contributing to delays in process
- Need for project manager
 - Project management/permitting for new gardens and program management for existing gardens are distinct roles

Barriers: Water & Land Permits

CURRENT STATUS

- In spite of waived water tap installation fees, establishment of water infrastructure is a convoluted and lengthy process:
 - Water tap plan is cost prohibitive and requires hiring engineer
 - Water meter application process is confusing for gardeners
 - Irrigation requires hiring master plumber
- Site plan exemption process requires professional site plan despite platting exemption outlined in City ordinance
- License agreement process and fee is prohibitively convoluted and long
 - New Travis County Clerk's Office Recordation Fee
- Lack of process for donating land to City for use for sustainable agriculture

Barriers: Need for Equity & Food Access Lens

- Lack of funding: Community Garden program has no budget to assist community with fees, organization/community outreach, material resources
- Sponsorship limitations: Liability insurance requirement & indemnification clause in license agreement prohibitive to most nonprofits interested in sponsoring CGs
- Lack of prioritization for garden assistance: Existing CGs in Austin serve a limited geographic area, especially in low income/low food access areas, and efforts & funding need to be prioritized accordingly
- Lack of City staff training to support program gardens, especially for recreation centers

Priorities for Action

- 1. Increase staffing for SUACG program by 0.5 FTE to restore staffing to 1.0 FTE as recommended by Council and City staff, and add 0.5 FTE for additional support, for a total of 1.5 FTE
- 2. Incorporate community garden support into relevant City staff job descriptions, as originally estimated by Fiscal Memo in 2009
- **3. Further streamline Community Garden Process** to minimize delays, permitting burdens, and financial burdens to community members
- **4. Fund SUACG program** in order to pay necessary fees and improve equity and access through increased capacity for technical assistance to underserved communities
- **5. Train City programming staff** to utilize existing and future program gardens at City facilities
