## CALL TO ORDER

Board Alexandra Evans called the meeting to order at 6:09 p.m.

# 1. CITIZEN COMMUNICATION: GENERAL

Speakers signed up prior to the meeting being called to order will each be allowed a three-minute allotment to address their concerns regarding items not posted on the agenda. – Lisa Hinely Chair of North Lamar Georgian Acres Planning Team. Transportation is a major issue. ATD \$700k in North Lamar. Multi-culturism—cannot speak to each other.

#### 2. STAFF BRIEFINGS

Raj Patel, UT LBJ School, Food for All Presentation (presentation provided in backup materials) Recommends that food policy board consider implications of study including the idea that defining "healthy" is something worth paying attention to. This area thinks that the City is dumping its lower quality food into the area. Key themes/policy recommendations: 1) appropriate information (language/knowledge), 2) availability, 3) accessibility (sidewalks, buses, safety), 4) affordability

(housing, SNAP/WIC)

Questions: Food access resolution, how does this tie in to the recommendations. Gaffney: Once report comes out, what are the next steps for implementing findings. Patel: As academics, strengths are in researching, getting loud about 25% food insecurity. Working with those that are good at doing (COA) to implement. Evans: 25% over all of Austin? Patel: Confident that numbers are even higher in Eastern Crescent. Mays: Most compelling part of this process? Patel: Teasing out the diversity of the community that can only be done when you engage in these conversations on the ground.

Is this separate from the \$400k. How do we advocate to continue funding for the \$400k if there is not anything to evaluate. Question: Do we review budgets as board? Budget and Policy working group to track.
