DATE OF ALLEGED VIOLATION: March 5, 2016

ACTIONS ALLEGED TO BE A VIOLATION:

Mr. Lemuel Williams who chairs the CTTC (Community Technology and Telecommunication Commission) has a created an environment of "pay to play" where he is directly asking for gifts from speakers at the commission.

On February 10 suddenly Mr. Hugh Forrest of SXSW was invited to our commission meeting. This was never discussed in previous meetings. This was a complete waste of time for the commission so we questioned why he was brought in. There was no answer. I was seeing many corruptions in the commission so I decided to resign because I refused to put personal interest before citizen's interest. In the month of March, I requested to see Mr. Williams's email through an PIR. I found that Mr. Lemuel Williams was actually asking for SXSW tickets from Hugh Forrest as gift and also 4 of them. These tickets are worth \$1200 each. I have attached this example. Mr. Williams not only took the tickets but distributed them behind our back. These were never mentioned to the commission or to city clerk's office. (attached email from Mr. Williams) Mr. Williams not only compromised his position — he distributed these tickets to other 3 women commissioners to get favor and in the process he compromised their position.

The email not only asks for gifts, but discriminates against other commission members based on their sex. This is a deeply offensive email

Mr. Williams also talks about looking for new leaders when he has no authority to do so because he is just one of 10.

This is a shameless exhibition of the corruption that is eating many parts of our city government. The commissions are supposed to be independent bodies and be eyes and ears of the council members to provide them the best possible advice.

WITNESSES OR EVIDENCE THAT WOULD BE PRESENTED: I would like to testify myself. I would also like to call Council Member Don Zimmerman who is represented by Mr. Williams in the commission. I would also like to provide a set of emails. (that are attached)
