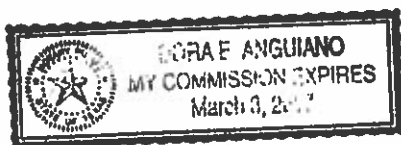

Your second degree relatives by consanguinity are your brothers, sisters, grandparents, and grandchildren. Your second degree relatives by affinity are your spouse's brothers, sisters, grandparents, and grandchildren, and the spouses of your brothers, sisters, grandparents, and grandchildren.
