Authorize execution of a construction contract with ALPHA PAVING INDUSTRIES, LLC., for the Annual Asphalt Repair 2016 Indefinite Delivery/Indefinite Quantity service contract in the initial amount of \$1,000,000 for a term of 12 months, with two 12-month extension options of \$1000,000, for a total contract amount not to exceed \$3,000,000 over an estimated three years or until financial authorization is depleted.

Amount and Source of Funding

Funding is available in the Fiscal Year 2015-2016 Operating Budget of the Public Works Department. Funding for the extension options is contingent upon future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information	

Indefinite Delivery/Indefinite Quantity contracts provide for an indefinite quantity of services for a fixed time, usually an initial term with extension options. They are commonly used when precise quantities of supplies or services, above a specified minimum, cannot be determined. Indefinite Delivery/Indefinite Quantity contracts help streamline the contract process and service delivery and allow the City the flexibility to add work as needs arise or change. As each project is defined, a specific work assignment will be given to the contractor who will complete the scope of work for the unit prices included in the contract. Work deadlines will be established for each work assignment.

The base bid was used to identify and determine the lowest responsive bidder and to determine contract unit prices for each bid item. The not-to-exceed contract amount of \$1,000,000 for the initial term, is the amount budgeted for this contract and Council authorization will allow the Public Works Department to issue work assignments up to the budgeted amount within the specified contract time.

This Indefinite Delivery/Indefinite Quantity contract will provide construction services for all necessary removal of existing temporary asphalt repairs and replacement with permanent hot mix asphalt concrete. The Annual Asphalt Repair Indefinite Delivery/Indefinite Quantity project is being undertaken as preventive maintenance for selected neighborhood streets across Austin. The project involves the removal and replacement of existing temporary asphalt repairs with permanent hot mix asphalt concrete type C mix.

This request allows for the award and execution of a construction contract with the recommended firm for an estimated period of one year with two one-year extensions. The extension options are subject to the mutual agreement of both parties and available funding.

Notification of issuance of an Indefinite Delivery/Indefinite Quantity for the subject services was distributed on April 11, 2016. Two firms submitted bids.

The contract allows 365 calendar days for completion of this project. This project is located within multiple zip codes and Districts. This project will be managed by the Public Works Department.
