Approve a resolution authorizing the issuance of Austin Housing Finance Corporation Multi-family Housing Revenue Bonds, in an aggregate principal amount not to exceed \$16 million; approving related documents, in substantially the form attached to the resolution, to provide financing for the rehabilitation of the Cross Creek Apartments, 1124 Rutland Drive, to be owned and operated by TMG-TX Austin II, LP, a Texas limited partnership; and authorizing specific named representatives of the Austin Housing Finance Corporation to execute the documents relating to issuance of the bonds and closing the transaction. (District 4)
