The purpose of the enclosed information is to alert the Commissioners to the historical importance of the Robert E. Lee School building, and of the current threat to the integrity of the building design as conceived by noted central Texas architect Roy L. Thomas in 1938. The undersigned intend to nominate the Robert E. Lee School building as a historic landmark. We believe that it is worthy of protection as such. The current debate over the name of the school threatens to result in the loss of a character defining element of the original design, specifically the Art Deco signage.

The Robert E. Lee School building has local, State and National significance as we will prove in the upcoming nomination. Lee is a product of Roosevelt's 2nd New Deal, as evidenced by the plaque in the building, is an excellent example of the early work of Roy L. Thomas, was the first "green" school in Austin (eg. non-coal burning), and is a fantastic example of the art deco style of architecture popular in the 1930's.

The information enclosed precedes the nomination in an effort to encourage dialogue between AISD and the Historical Landmark Commission. Protecting the Robert E. Lee School building as a valuable part of Austin's architectural history means preserving it as it was conceptualized in 1939. As you can see in the enclosed photographs, Lee looks today very much like it did during the Roosevelt Administration, and we would like to keep it this way for future generations of Austinites.

We the undersigned ask the Commissioners to take action to protect this important building that has an exceptional place in our history.

Robert E. Lee School

Building History

Construction on the Robert E. Lee School building began in October of 1938 and was completed in October of 1939. The architect for the school building was Roy L. Thomas. The school opened with 13 classrooms, a library, small cafeteria, small office, an auditorium, and boiler house. It was the first school in Austin to run on natural gas instead of coal.

Robert E. Lee School was built with Federal funding from the Public Works Administration. During the school year of 1938, an announcement came from the Washington Office of Congressman Lyndon B. Johnson that a WPA grant of \$613,127 had been made to the city of Austin for school improvement. These funds combined with a \$600,000 bond issue voted by the citizens of Austin made \$1,213,127 available for buildings and grounds, which up until that time was by far the largest amount of money made available for any one school in Austin's history.

The New Deal Legacy

In the depths of the Great Depression, President Franklin D. Roosevelt promised the American people a "New Deal." Over the decade 1933-43, a constellation of federally sponsored programs put millions of jobless Americans back to work and helped to revive a moribund economy. The Living New Deal's purpose is to make that enduring legacy visible.

Today, our team is building a national database of thousands of documents, photographs, and personal stories about public works made possible by the New Deal. And it's all just a click away on our national map of New Deal public works sites. California's leading historian and former State Librarian, Kevin Starr, has likened the Living New Deal to a WPA project from the 1930s in its ambition and scope.

Keeping the Legacy Alive

Far from an antiquarian exercise, the Living New Deal aims to help preserve New Deal art and architecture from destruction or privatization, to see that New Deal sites are properly marked, and to help communities and families across the nation rediscover their heritage.

The Living New Deal is even timelier because of the worldwide economic crisis of 2008-2012, which invited so many comparisons with the Great Depression of the 1930s. For five years the unemployment rate hovered near 10 percent, wages stagnated; home foreclosures were epidemic, and national growth anemic. Many people called for a *New New Deal* to relieve the severe distress of millions of Americans. Instead, most government programs shrank, infrastructure continued to decay, and the wealthiest 1% gained a larger share of national income.





Robert E. Lee Elementary School was one of the new schools built with this grant.




Construction on Robert E. Lee School began in October of 1938 and was completed in October of 1939. The architect for the school building was Roy L. Thomas. The school opened with 13 classrooms, a library, small cafeteria, small office, an auditorium, and boiler house. It was the first school in Austin to run on natural gas instead of coal.

In 1950, a small detached cottage on the southwest side of the property was-purchased-and-used-as a center for two sections of mentally retarded children.

In 1952, a larger lunchroom, playroom, and renovations to the administrative area were added. Roy L. Thomas was also the architect for these additions and renovations.


In December of 1986, three new kindergarten classrooms were completed. A detached library building was completed in 1988.


Robert E. Lee School is the only elementary school in Austin built to have an auditorium which seats its entire population of students.






Biography of Roy L. Thomas

A. Origins

Roy Leonidas Thomas was born September 12, 1886, in San Marcos, Texas. His parents were some of the earliest settlers in San Marcos. His father was a banker, and his mother was an artist. He first came to Austin in 1906 to enter the University of Texas. He died in Austin at the age of 81 on November 22, 1968.

B. Education

Thomas grew up in San Marcos and graduated from high school there in 1904. That same year he took a course in McGee Business College. In the fall of 1905 he entered Southwestern University in Georgetown; in the fall of 1906 he enrolled in the School of Engineering at the University of Texas in Austin and remained until the spring of 1908. During his high school and college years he worked in the summers as carpenter's helper for contractors Sam Baynes, Beasley and Hightower building houses in San Marcos. After leaving the University, he spent a year with Mr. Beasley superintending construction. Working alongside John Gary, a plumber working with Mr. Beasley, Thomas invented a ratchet pipe cutter for which he obtained a patent.

C. Professional Practice

In September of 1909 Thomas took a job as a draftsman for the firm Endress and Walsh in Austin. Some buildings being planned during this time were the Goodall Wooten Home on Rio Grande, E.H. Perry home on Lavaca, Judge Batt's home, and Dr. Henderson's home. Some schools coming out of this firm were Baker, Fulmore, and Metz. In 1910 the firm sent Roy down to San Bonita as a supervisor for three buildings, the Sam Roberson home, the Haywood bank and a school. While in San Bonita he drew plans for and supervised a garage for E.L. Bernard, C.E. McAllister's home, W.B. Hinkley's home, and the Farmer's State Bank of San Bonita. After returning to Austin, he supervised the building of the Rather Home (plans by Brigham, Covney, and Bissby of Boston).

In June of 1911, Roy left Endress and Walsh and worked two months in the Page Brothers' office. That year he opened his own office in the Scarbrough Building.

In 1913 he had been successful enough in his practice to buy his first car, a Ford Model T Roadster, and to marry Ruth Beaver in September.

When the U.S. declared war on Germany, Roy was offered a place in the Key West Navy Yards as an architectural draftsman in the Department of Public Works and he and his wife and two children moved to Key West in September of 1917. Here he remained until 1919 when he moved back to Austin and opened an office in the Littlefield Building. In November of 1933 Thomas moved his office out to his home 2812 Hemphill Park where it remained the rest of his life.

The Texas Legislature passed the State Architects License Law in 1937. Thomas had been practicing 26 years then, and received his state license December 6, 1937, No. 332. When the Austin branch of American Institute of Architects was organized in 1938, Thomas became a charter member. The title "Member Emeritus" was conferred upon him when he officially retired on December 31, 1961.

During the years of World War II when the building industry slowed down Thomas worked for the International Mineral and Chemical Corporation here in Austin as supervisor of construction of the Magnesium plant, and as supervisor of a Federal Housing Unit in San Marcos. Also during the latter 30's and 40's he worked as a Fee Architect Inspector with the Federal Housing Administration.

In 1944 he reopened his office. In 1946 his son William (Billy) came back from his military duty and became a partner in his father's business. Billy had attended the University of Texas from the fall of '36 through the spring of '39 enrolled in the School of Engineering.

The scope of Roy Thomas work covered many building types. He designed homes, schools, churches, commercial buildings, apartment houses, service stations, tourist courts; he liked to do remodeling and renovation. As styles in architecture changed in popularity through the years, so did his ability to adapt to the wishes of his clients. Neoclassical, Colonial Revival, Tudor, Prairie, Spanish Eclectic, Craftsman, Modernistic, Ranch influences can be found in his work. He subscribed to the architectural magazines: "Architectural Forum", "Progressive Architecture", and "Architecture Record". His peers speak of his thorough understanding of structural and mechanical processes and of his ability to supervise the building process; they praise his diligence in requiring the highest standards of craftsmanship in his own development of plans and specifications as well as expecting the same standards of excellency from his workers. He was honest, courteous, and got along well with his co-workers. Each person interviewed testified to his Christian character, and dedication to his family. One

of his former draftsmen who went on to become an architect spoke of him as the "finest man he had ever known." He built not only in Austin but all over the Central Texas area.

Thomas was a lifelong member of the University Methodist Church where he served as a steward.

General contractors with whom Thomas worked in the construction of his buildings are John M. Monk, Barney P. Slaughter, T.E. Sanderford, (Belton), Lewis Dobie, H.R. Fischer, Wilson and Cottingham, (structural engineers), A.T. Moses, (mechanical engineers), Frank R. Rundell, Schwarzer and Lorey, Roy Starling, N. Stravos Nayfach (San Antonio), C. Ben Hibbitt, Ernest Parker, D.& D. Construction Co., C.H. Toungate, E.A. King, H. C. Epperson, Moore Construction Co., Holland Page, Wm. Peterson, Frank Sefcik, (Taylor), H. R. Fischer, Ed Mallett, Gus Fritz, T.J. Brown, A.W. Bryant Construction Co., E.D. Walker, E.E. Drake, Ed Mallett. Mr. Weigl of Weigl Iron Works was a friend of Thomas's and designed ornamental iron work for some of his buildings. Another well-known-artist-craftsman contemporary with Thomas as well as friend was Peter Mansbendel.

Many young students worked as draftsmen in Thomas' office over the years; several are recognized as some of Austin's most outstanding architects today. Billy Bass, Milton Pearson, Mary Halloway, Hilda Urbanke, Worth Cottingham, Twit Murchison, Roger Small, Roy White, Benny Kotan, Edward Hildebrandt, Howard Barr, Louis Sutherland, Leonard Lundgren, Louis Hamby, Richard Wroe, Ben Hibbetts, Mr. Pohl, Norman Arlitt, Ralph Huber, Doak Raney, Roy McChristian, Mr. Menifee, John Williams, Jim Lions.

One of the more outstanding designs produced by Thomas' office, the Herbert Bohn House, has been featured in publications. The "Austin Building Magazine" wrote an article about the Bohn home during its construction. An article also was published in the April, 1985 issue of "Austin Homes and Gardens", which divulged sources of inspiration for Mr. Bohn's ideas about the design of his home.

Another of Thomas' buildings, the R.M. Kennedy house in Taylor, is pictured in Virginia & Lee McAlester's book <u>A Field Guide to American Houses</u>, as an example of a Neoclassic style.

Biographical Sketch of Roy L. Thomas

Roy L. Thomas designed a number of important Austin buildings from the 1920s through the 1950s. The scope of his work covers many building types: homes, schools, churches, commercial buildings, apartments and service stations.

Thomas was born in San Marcos, attended Southwestern University in Georgetown in 1905, and enrolled in the school of engineering at the University of Texas in 1906. He left UT in 1908 and spent a year in San Marcos as a construction superintendent. In 1909 Thomas took a job as a draftsman with Endress and Walsh, Austin, and worked on the firm's behalf in San Benito. In 1911 he opened his own practice in the Scarbrough Building. He served during World War I as an architectural draftsman for the Department of Public Works in the Key West naval yards. In 1919 he returned to Austin and in 1933 he established a permanent office at his home, 2812 Hemphill Park. He was president of the Hill Country Chapter American Institute of Architects in 1935.

During World War II he supervised construction of a magnesium plant for the International Mineral & Chemical Corp. In 1944 he organized a partnership with his son, William, back from military duty. They practiced together through the 1950s. William died in 1967; Roy, a year later.

One of the more memorable designs produced by Thomas' office is the Herbert Bohn House (1938), 1301 West 29th St. Other Thomas works are the Stephen F. Austin Hotel (1924) at 701 Congress, Robert E. Lee Elementary School (1939) at 3308 Hampton Rd., Tarrytown Methodist Church (1947) at 2701 Exposition, and Ebenezer Baptist Church (1954) at 1010 East Tenth St.

Scope and Content of the Collection

Correspondence, office files, financial records, job files, specifications, floor plans, photographs, maps, and drawings document the career of Austin architect, Roy Thomas (1886-1968). The record group dates from 1910 to 1966. Information about Thomas' buildings, including the job files, specifications, and 10,000 drawings constitute the bulk of the material.

Job files contain client correspondence, newspaper clippings, and some photographs. These files document the quantity and variety of Thomas' projects. Among the types of buildings he designed were churches, residences, and public buildings. Included in this collection is information on the following projects: the Herbert Bohn residence, Robert E. Lee Elementary School, Ebenezer Baptist Church, and the Stephen F. Austin Hotel on which Thomas worked as supervising architect.

The floor plans are drawn in pen and ink on drawing board, showing the footprint of the building (usually residences). Some of the floor plans are overlaid with Thomas' sketch of the exterior of the building.

The map series contains maps of Austin and the surrounding areas, dating from 1910 to 1949.

The photograph series consists of a folder of unidentified photographs and a set of construction photographs of the Stephen F. Austin Hotel. The Austin History Center of the Austin Public Library also holds a collection of Roy Thomas photographs. The Alexander Architectural Archive has a binder of photocopies of the photographs kept with the paper finding aid for this collection.
