i. Dustin Fedako: What are the three new districts? Klepadlo: Not yet defined. Interest on Airport, North Lamar. Announced in next 60 days. Recently heard from Rundberg group. Partnered with Public Works and other departments to address low hanging fruit (ex: sidewalks and poor lighting). Transportation and Police have been most responsive because safety has been recurring concern.

4) OLD BUSINESS

- a. Board Infrastructure & Protocol
 - i. Review Board Members' meetings with City and County Officials
 - 1. Board Member Jessica Gaffney has meeting planned with Council Member Kathie Toyo.
 - 2. Board Member Adrienne Haschke has meeting planned with Mayor's Office staffer, Brandi Clark Burton, and Sarah Eckhardt staffer.

- b. Board Recommendations
 - i. Local and Healthy Food Procurement City staff met with local institutions to introduce procurement framework developed by Los Angeles Food Policy Council. Three large institutions expressed interest in participating in local pilot-AISD, UT, Central Health. Next steps will be for each institution to reach out to vendors and get information about the products they are purchasing, send information to Center for Good Food Purchasing in Los Angeles to them help with a baseline assessment. Following the baseline assessment, institutions will then set goals to challenge themselves to make better decisions about what they purchase. After a year of tracking, celebrate successes.
 - ii. Healthy Food Access Funding
 - 1. Healthy Corner Store Initiative (HCSI) RFP sent out and contractor has been selected
 - 2. Evaluation RFP for HSCI wrapped up in next couple of week
 - 3. School and Community Farm Stands in draft form
 - 4. Mobile Farmers Market being vetted, released within next two weeks
 - 5. Double Dollar Program sole source contract through Sustainable Food Policy
 - 6. All funding must be utilized by Oct. 1; all are renewable contracts, they won't have to be re-released as RFP's.
 - 7. Questions: Dustin Fedako: What is the timeline for release of RFPs? City Staffer Edwin Marty: As soon as possible; Health and Human Services Department has many positions that need to be filled as well as development of several RFPs due to the new funding approved by Council. Follow-up Question from Board Member: What was money for? Edwin Marty: Half for contracts, half for filling voids where chronic disease needed funding. Many positions at HHSD have traditionally been funded by grant funding however now there has been money added into permanent budgeting process. Board Members request for HHSD to come to future meeting for presentation.
