Description of item: **Change to the Responsible Organization to hold the nomination/election for the East Austin Geographic Area Designated by Resolution No. 20150618-081, under Section 2-1-127 of the City Code.** The City of Austin Health and Human Services Department receives Community Services Block Grant (CSBG) funds which require at least one third of the CSBG Advisory Board be representatives of low-income individuals and families who live in the neighborhood they represent, and who are chosen in a democratic selection process. The Community Development Commission serves as the required CSBG Advisory Board for the City of Austin. The East Austin Advisory Board cited in the current resolution is no longer active. The East Cesar Chavez Neighborhood Plan Contact Team has agreed to serve as the new responsible organization to hold the nomination/election process for a representative from the East Austin Designated Geographic Area. The Community Development Commission has recommended the attached resolution be changed to allow the East Cesar Chavez Neighborhood Plan Contact Team to serve as the new responsible organization who will hold the nomination/election for the East Austin area.

**RESOLUTION NO. 20150618-081**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

Under Section 2-1-127 of the City Code, the council designates each of the listed geographic areas to have a commissioner on the Community Development Commission to represent the area. For each respective area, the council designates the listed organization to nominate a person to serve on the commission in the seat designated to represent the area.

1. The Colony Park area is that part of the City south of the north boundary, north of the south boundary, and east of the west boundary, as follows:
  - North boundary - U.S. Highway 290;
  - South boundary - F.M. 969;
  - West boundary - U.S. Highway 183.

The nominating organization for the Colony Park area is the Colony Park Neighborhood Association.

2. The Dove Springs area is the area within the following boundaries:
  - North boundary - Ben White Boulevard;
  - South boundary - Starting from the intersection of Brandt Road and Interstate Highway 35 proceed east on Brandt Road to Bluff Springs Road, then south on Bluff Springs Road to Nuckols Crossing Road, then east on Nuckols Crossing Road to Thaxton Road, then east on Thaxton road to Salt Springs Drive, then north on Salt Springs Drive to Colton-Bluff Springs Road, and then east on Colton-Bluff Springs Road and McKenzie Road to U.S. Highway 183;
  - East boundary - U.S. Highway 183;
  - West boundary - Interstate Highway 35.

The nominating organization for the Dove Springs area is the River City Youth Foundation.

3. The East Austin area is the area within the following boundaries:
  - North boundary - East 7th Street;
  - South boundary - Lady Bird Lake;

- East boundary - Airport Boulevard, U.S. Highway 183;
- West boundary - Interstate Highway 35.

The nominating organization for the East Austin area is East Austin Neighborhood Advisory Board.

4. The Montopolis area is the area within the following boundaries:

- North boundary - Lady Bird Lake;
- South boundary - Ben White Boulevard;
- East boundary - U.S. Highway 183;
- West boundary - Interstate Highway 35.

The nominating organization for the Montopolis area is the Montopolis Neighborhood Advisory Board.

5. The Rosewood-Zaragosa/Blackland area is the area within the following boundaries:

- North boundary - Airport Boulevard, Manor Rd, Martin Luther King Jr. Boulevard;
- South boundary - East 7th Street;
- East boundary - U.S. Highway 183;
- West boundary - Interstate Highway 35.

The nominating organization for the Rosewood-Zaragosa/Blackland area is the Rosewood-Zaragosa/Blackland Advisory Board.

6. The St. Johns area is the area within the following boundaries:

- North boundary - U.S. Highway 183;
- South boundary - East 51st Street;
- East boundary - U.S. Highway 183;
- West boundary - Interstate Highway 35.

The nominating organization for the St. Johns area is the St. Johns Neighborhood Association.

7. The South Austin area is the area within the following boundaries:

- North boundary - Lady Bird Lake;
- South boundary - East Ben White Boulevard;
- East boundary - South Interstate Highway 35;
- West boundary - South Lamar Boulevard.

The nominating organization for the South Austin area is the Dawson Neighborhood Association.

8. The North Austin area is the area within the following boundaries:

- North boundary - Braker Lane;
- South boundary - Starting from the intersection of Burnet Road and Anderson Lane proceed east on Anderson Lane to Lamar Boulevard, then south on Lamar Boulevard to St. Johns Avenue, then east on St. Johns Avenue to Interstate Highway 35, then North on Interstate Highway 35 to U.S. Highway 183, and then east on U.S. Highway 183 to Cameron Road;
- East boundary - Cameron Road and Dessau Road;
- West boundary - Burnet Road.


The nominating organization for the North Austin area is Austin Voices.

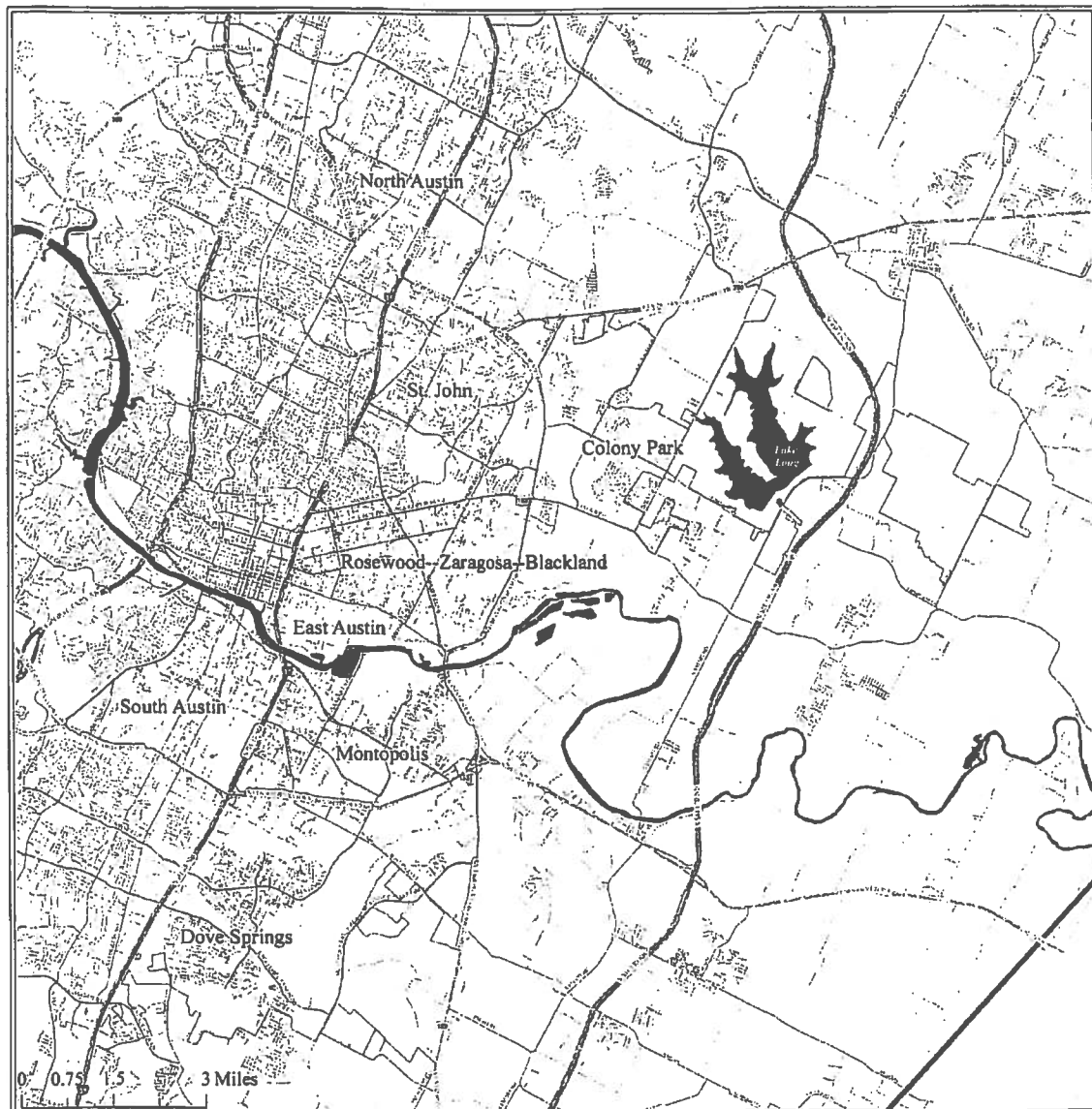
