Authorize execution of a 12-month contract through the GENERAL SERVICES ADMINISTRATION cooperative purchasing program with GENERAL SALES ADMINISTRATION, INC. DBA MAJOR POLICE SUPPLY to provide the Vigilant Solutions Automatic License Plate Recognition System in an amount not to exceed \$350,000, with five 12-month extension options in an amount not to exceed \$110,000 per extension option, for a total contract amount not to exceed \$900,000.				
Amount and Source of Funding				
Funding in the amount of \$350,000 is available in the Fiscal Year 2015-2016 Operating Budget of the Austin Police Department. Funding for extension options are contingent upon available funding in future budgets.

Additional Backup Information				

The contract is for the purchase of the Vigilant Solutions Automatic License Plate Recognition System (ALPR) for the Austin Police Department's (APD) Auto Theft Interdiction Project (ATIP). Vigilant Solution is the largest data-sharing network in the United States, which will enable the City to obtain critical information from one source. The Vigilant Solution enables more than 217,000 law enforcement agency-to-agency license plate reader data sharing relationships in the United States, enabling agencies to assist one another in solving investigations. The compatibility of these systems is critical to effective operations and investigations. The hosted solution is limited to law enforcement use only.

This contract will provide a highly secured, turnkey ALPR solution to be mounted on patrol vehicles, portable trailers, and affixed to stationary roadside structures. The contract includes project management, design, installation, set-up, configuration and testing, training, and post implementation support of the solution to meet the City's functional and technical requirements. The system will be scalable for future expansion and integrate seamlessly with hosted data sources and the City's existing state, national and local databases of stolen vehicles and vehicles of interest data.

The ALPR systems automatically capture images of vehicle license plates and compare the plate numbers with license plates on hotlists that include stolen license plates and plates associated with stolen vehicles. The ALPR systems are used by APD's Auto Theft Department to meet the goals of the ATIP to include:

- Reduce auto thefts and related crimes involving vehicles;
- Increase auto theft vehicle recovery rates;
- Increase the apprehension of suspects for auto thefts, burglaries and any other crimes involving a vehicle;
- Increase the solvability of crimes involving a vehicle;
- Reduce the overall cost to citizens through the reduction of insurance costs associated with vehicle related crimes, property recovery, and prosecution;
- Increase investigative leads to reduce auto thefts and vehicles used in gateway crimes (i.e. robbery, burglary of residence, etc.); and
- Reduce insurance loss.

ALPR are critical technology in solving crimes. Without such technology, capturing and running license plate data will have to be manual, which is time-consuming, inefficient and ultimately costs taxpayers.

The General Services Administration cooperative purchasing program has been competitively bid and negotiated, and offer discount off open market pricing.

This item was postponed for vote by Council on May 19, 2016 and June 9, 2016. APD changed funding sources from the Police Federal Department of Treasury Asset Forfeiture to the Operating Budget prior to the June 23, 2016 meeting. Council approved negotiation of the contract on June 23, 2016; however, execution of the contract is contingent upon Council pre-viewing the contract to ensure that APD owns all data collected through the APD owned ALPR systems and such data is maintained in secure fashion and in strict accordance with APD and City policy. APD will not collect any revenue through warrants or similar court orders by using data collected from the City ALPR system. All of Council's requested information has been included in the contract.
