Authorize award and execution of a 36-month contract with CENTEX MATERIALS, LLC, to provide ready mix concrete, in an amount not to exceed \$532,500, with three 12-month extension options in an amount not to exceed \$177,500 per extension option, for a total contract amount not to exceed \$1,065,000.				
Amount and Source of Funding				
Funding in the amount of \$14,792 is available in the Fiscal Year 2015-2016 Operating Budget of the Parks and Recreation Department. Funding for the remaining 35 months of the original contract period and extension options are contingent upon available funding in future budgets.

Purchasing Language:	The Purchasing Office issued an Invitation for Bids (IFB) SMB0102 for these goods on May 9, 2016, and it closed on May 31, 2016, with one offer received. Additional Backup Information

The contract will provide ready mix concrete for various Parks and Recreation Department (PAR) projects, such as curbs, sidewalks, retaining walls, and installation of park equipment. The contractor will furnish and deliver four different types of concrete to various sites at specific delivery times requested by the City.

The contract is necessary to ensure that ready mix concrete is readily available for PAR projects on the days and within the time windows needed. Without a contract, PAR will continue to make small one-time purchases for ready mix concrete, resulting in higher prices and delayed delivery.
