Item #	Domain	Request (Type)	Description/Justification
1	Outdoor Spaces & Buildings	PARD	Assess number of parking spaces in relation to the number of spaces compliant with the ADA, i.e., those reserved for persons with handicap parking permits. Wherever viable, convert pre-existing parking spaces into parking spaces compliant with the ADA.
2	Outdoor Spaces & Buildings	PARD	Provide multigenerational programs such as yoga, Tai Chi, art in the park, etc. in neighborhood parks. (Consider classes taught by volunteers.)
3	Outdoor Spaces & Buildings	PARD	Assess number and location of benches and other seating at City of Austin parks and where possible ensure there is sufficient seating to allow persons with physical limitations to enjoy the amenity.
4	Transportation	Public Works 2016 Sidewalk Master Plan	Remove vegetation adjacent to sidewalks to increase pedestrian infrastructure and safety.
5	Transportation	CapMetro	Promote existing public transportation discounts to older adults and encourage more.
6	Transportation	PARD	Review City of Austin PARD's Senior Transportation program and explore ways to expand capacity with additional vehicles, drivers and a larger service area.
7	Transportation	HHS	Remove barriers to social service contracts to permit agencies providing transportation services to older adults to better access social service city funded contracts.
8	Transportation	Public Works	<ul> <li>Require that when replacing missing street sign/traffic signage, it is easily readable, well-lit at night, and addresses the access and functional needs of older adults.</li> </ul>
9	Housing	Neighborhood Housing and Comm.Dev	Promote existing home repair, rental assistance and property tax discounts for senior homeowners.Promote the work of and expand support for the Austin Housing Repair Coalition.
