

## M/WBE Summary

Public notice was given for this solicitation, CLMC574 Justin Lane, Burnet to Lamar St. Reconstruction & Utility Adjustment, through the City's Vendor Connection web portal which resulted in 468 contractors receiving notification. Fifteen contractors obtained the bid documents and seven bids were received and opened on May 19, 2016. Four out of seven bids received were certified MBE/WBE certified firms. Facilities Rehabilitation, Inc. submitted the lowest responsive bid of 7 bids received (including \$150,000 allowance):
