PROPOSAL

Demolish a ca. 1951 house.

ARCHITECTURE

One-story, rectangular-plan, stone-veneered frame house with an integral one-car garage; single and paired 1:1 fenestration with a small, under-eave entry hood as part of the design of the roof.

RESEARCH

There are building and utility permits dating from 1951 for this house, but the address does not appear in city directories before 1959. The first known owners and occupants of the house were Cecil and Maurgret Fogle, who lived here until around 1963. Cecil Fogle was an electrician; Maurgret Fogle was the proprietor of a beauty shop on San Jacinto. Through the rest of the 1960s and early 1970s, the house was a rental property, with student tenants. Around 1972, the house was purchased by Lee M. and Mary L. Nelson. Lee M. Nelson was a painter at the University of Texas. From the mid-1970s onward, the house was owned by Mary Louise Nelson, who was an accountant for the State Board of Vocational Nurse Examiners until her retirement.

STAFF COMMENTS

The house is not listed in any City survey to date.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance for designation as a historic landmark.
